#### LOG MILEAGE

2010 Mileage Logs have been mailed to all archdiocesan and extern priests to track their professional miles driven. Please remember to log the automobile odometer reading on January 1, 2010 and then log all professional miles driven throughout the year. Record the odometer reading on December 31, 2010, thus providing the total miles driven for the year. By adding the total number of professional miles driven a ratio of professional versus personal determined can be (e.a. miles professional, 40% personal). The total amount of car expenses for the year is determined (e.g. depreciation allowance, insurance, gas, repairs, etc.). The percentage of the total expenses that is equal to the percentage of the professional use of the car (60%) is exempt from taxation. The percentage of the car expense equal to the percentage of the personal use of the car (40%) is added to the priest's taxable income.

2009 Mileage Logs must be given to the parish bookkeeper in early January so that the priest's taxable income can be computed. IRS regulations required that the parish keep the log in case of an IRS audit. Failure to provide the bookkeeper with a completed log of business related mileage will result in ALL car expenses being considered personal and the priest will pay tax on the total amount of yearly car expenses, over \$7,000 in additional income. The log is the only proof that the priest has used his car for professional purposes, hence if no log is maintained the IRS does not allow exemption of a portion of car expenses from taxable income.

#### IRS MILEAGE RATE

Beginning January 1, 2010, the IRS standard mileage rate for 2010 reimbursement for miles driven for professional purposes is 50 cents/mile. This is a decrease from the 2009 calendar year.

#### FIRST RECONCILIATION

Some parishes have taken the practice of giving certificates for First Reconciliation as well as creating a register. The confidentiality of the Sacrament of Penance should always be kept in mind when recording First Reconciliation. It is recommended that a parish may record that the requirements for receiving the Sacrament of Reconciliation have been met. If a parish decides to keep a record of those who have completed these requirements, **do not** send notification to the places of baptism for recording in the sacramental books.

#### LITURGICAL CONFERENCE

Fr. James Burkart, chairperson for the January liturgical conference, Jan 13-16. extends a special invitation to all priests. "We priests and pastors are constantly looking for ways to assist the hundreds of faithful who are liturgical ministers to become more competent in their various ministerial duties. We lament that we, ourselves, do not have the time to spend with all of the different ministries and persons within them. Please, do not let this opportunity pass you and your parish by. We are also offering two clergy tracks, one on Thursday (homiletics in a multicultural setting) and Friday (Roman Missal). Workshop are offered for beginners to professionals. A track entirely in Spanish is offered on Saturday of the conference with a general session and 18 workshop sessions. There are some scholarships offered through the Office of Worship. #### CHARITABLE CONTRIBUTIONS AND IRS

Please place in your bulletins the following information concerning the tax laws governing charitable contributions.

"Due to changes in the tax laws, parishioners (those who itemize their tax returns) will no longer be able to deduct contributions to the parish unless they maintain a bank record or written contribution statement from the parish. If you want to ensure deductibility of your contributions to the parish, please use a check, direct deposit from your bank account, or your parish envelopes. The parish will track contributions made using parish envelopes, and will upon request, produce a written statement of contributions made during Cancelled checks and other bank records are also sufficient documentation. The parish cannot track cash contributions that are not in parish envelopes."



My brother priest:

The national Collection for the Church in Latin America is scheduled for the weekend of January 23-24, 2010. The Church in Latin America boasts the world's largest Catholic population. However, a study commissioned in the late 1990s by CELAM, the federation of Latin American Catholic bishops' conferences, found that Latin Americans were leaving the Church at the alarming rate of approximately 8,000 people each day.

This exodus is the result of complex reasons, ranging from the strain that economic globalization places on communities to well-financed competition from other groups, that are drawing people away from the Church. Because of a very low priest-to-parishioner ratio, and the local churches' inability to support the substantial number of parishioners, many of the faithful often seek a personal experience and closer sense of community elsewhere. In addition, migration across the region can rupture the bonds of family and community in which faith is nurtured and can grow.

To confront these tendencies, the Collection for the Church in Latin America supports pastoral projects that engage Latin American parishioners in their faith, strengthening their sense of mission and identity with the Church. Your generous support of the Collection provides evangelization in rural and poverty-stricken areas, religious training, and catechesis and formation programs. The cost of a daily cup of coffee could provide a young girl with her First Holy Communion book.
