#### **ALL SAINTS DAY**

Because All Saints Day falls on a Monday this year, the obligation to attend Mass is dispensed. At least one Mass for the Solemnity still is to be celebrated. Because the obligation is dispensed, a funeral Mass is permitted on that day.

#### ALL SOULS DAY AND MASS STIPENDS

A practice seems to have developed in some parishes that for All Souls Day parishioners are encouraged to write down the names of deceased loved ones and with a donation, place the envelope in the collection. The All Souls Day Masses are celebrated for all the named persons and the priests distribute entire collected amount themselves. This practice is scandalous and violates the law of the Church regarding Mass stipends. In 1992 the Congregation for the Clergy issued a directive on Collective Mass Intentions. In this document it is stated that the Church allows on rare occasions the combining of Mass intentions as long as the faithful are explicitly informed that the Mass intentions will be combined. In these cases, however, the priest may only take the dollar amount equal to one stipend (\$5.00 in the dioceses of Texas). The rest of the stipend offering is to be forwarded to other priests to fulfill the Mass intentions or to the chancery for forwarding to The text of the missionary priests. Congregation's directive can be found in the Eucharist section of the diocesan Pastoral Manual.

Please do not allow political literature to be distributed by parishioners or anyone else in the Church or on parish property unless it is voter education material prepared by the USCCB or has the specific approval of the Archbishop's office.

To my brother priests in Christ:

World Mission Sunday will be celebrated on October 24, 2010, during the weekend celebrations of the Eucharist. I am writing to request your help in encouraging prayer and generous support for the missionary work of the Church.

When the United States was a young and growing church, just a little more than a century ago, we relied on the generosity of fellow Catholics from Europe for our pastoral and evangelizing needs, through the Society for the Propagation of the Faith. Today, the young churches of Asia, Africa, the Pacific Islands and remote regions of Latin America count on similar help. The prayers and generous financial support offered in our parishes on World Mission Sunday are essential to these local mission churches – to places like Bomadi in southern Nigeria.

"Ready to work." That's what Bishop Hyacinth Egbebo of the Diocese of Bomadi says he and others serving in that local Church are ready to do. "We need to spread out and proclaim the Good News of Jesus to the poor here," he says. "And we need to get working *now*!"

According to Bishop Egbebo, in this area of primary evangelization, there are 19 parishes – and eight more that need to be created. Some 26 local and missionary priests serve the church, along with four Religious Sisters. His plan is to spread his priests out, through the new parishes. Bishop Egbebo states his mission succinctly: "We are prepared to go where we are sent, and make Christ known in every way possible."

Indeed, together, in prayer and sacrifice, we continue the Lord's mission to the poor and suffering, partnering with local priests, religious and catechists throughout the Developing World – just like those in Bomadi, Nigeria. Your voice – telling about the Missions and encouraging your people's generous and enthusiastic participation in the Eucharistic celebration that October Sunday – is also vitally needed.

Please know how grateful I am for all you will do to ensure the fullest celebration of World Mission Sunday. Know also that you and those you serve remain in my prayers.



## PRESBYTERAL COUNCIL

Archdiocese of Galveston-Houston

Minutes Meeting of August 3, 2010

The Council met in the Board Room of the Nold Education Building at St. Mary's Seminary. Cardinal Daniel DiNardo presided. Fr. Sean Horrigan called the meeting to order at 10 a.m. Fr. Dwight Canizares offered the Opening Prayer. Fr. Paul Felix took the roll.

<u>MINUTES</u>: The minutes of June 1, 2010 were accepted as presented. Msgr. Rossi moved the acceptance of the minutes and Msgr. Borski seconded it. They were accepted by a voice vote.

<u>UPDATE ON PENSION PLAN AND SHORT TERM DISABILITY:</u> Mr. David Hessel, Chief Financial Officer for the Archdiocese, accompanied by Ms. Heidi Henrichs, Controller, presented on the following 3 items:

#### Pension:

Ms. Henrichs explained the department is working to fine-tune procedures for the handling and accounting of pension fund receipts. There are 12 entities (five parishes, seven schools) that have not made pension fund contributions for 2010. These institutions will be contacted in an effort to remedy the problem. There are no clear guidelines on payment of pensions. There is a need for a "true up" invoice aimed at bringing accounts current.

Efforts are being made to identify ways in which we can narrow the gap on unfunded pension liabilities. Ms. Henrichs asked the Council's input on a proposal of a 6.5% contribution of total payroll to fund pensions. This would help narrow the gap for unfunded pension liabilities. It would simplify the calculation of process of who is and

who is not eligible for pension. The current system of determining who is eligible, in view of all the exceptions, makes it very difficult to calculate accurately and some people end up not receiving a pension.

The Council had numerous questions for clarifications and comments were offered, but no final decision on the proposal was announced at this time.

#### Departmental Program Review:

Mr. Hessel updated the Council on the Chancery departmental review that is underway. A committee of chancery personnel and several pastors is reviewing how the many departments of the Chancery can be run more efficiently and take advantage of good stewardship practices. The committee is reviewing all programs with respect to both the qualitative and financial aspects. They are considering various options including the combining of programs to avoid duplicating efforts and better matching programs and department with personnel needs. The committee's findings will be shared with the Council at a later date when completed.

#### Proposals of Changes to Ancillary Insurance Programs:

Mr. Hessel said there are various insurance programs and ancillary benefits that are under consideration in an effort to provide additional support and assistance to employees. Among the programs under consideration are group life health, an employee assistance program, and a travel assistance program. The potential cost increase is estimated to be in the area of \$10 monthly per employee. Such an upgrade in the benefits package could potentially make the Archdiocese a more attractive employer in the marketplace.

<u>VISION STATEMENT FOR PRESBYTERAL COUNCIL</u>: Msgr. Bill Young submitted a proposal for the Council to prepare a vision statement for the presbyterate of the Archdiocese. There was good discussion on the proposal and the Council thanked Msgr. Young for his efforts on behalf of the priests. The Council recommended that the proposal might be more appropriate for adoption and implementation at the deanery level. Deans will receive a copy of the proposal to discuss at upcoming deanery meetings.

REPORT OF YOUTH OFFICE ACTIVITIES: Mr. Brian Johnson, Director of the Office of Youth Ministry, presented an overview of the direction and activities in Youth Ministry. The Office recently concluded its largest ever Archdiocesan Youth Conference (AYC), and has a list of goals and plans that look toward the year 2013. Youth Ministry focuses its efforts on three distinct groups: younger adolescents (essentially junior high youth), older adolescents (high school students), and finally, the adults who serve and minister to and with them.

He presented the program known as "Jeremiah 1:7" for training and formation of teenagers assisting in programs serving younger children. The Safe Environment Program doesn't currently have a component oriented to teens in leadership, and the Jeremiah 1:7 program is receiving good reviews. Mr. Johnson moved on to a discussion concerning the necessity of catechesis being at the heart of youth ministry. He shared his concern and desire to work with newly hired youth ministers who come from college with

degrees but not the skills that can only be acquired through experience. There is difficulty in getting some of the youth ministers into a formation program oriented to develop their skills. Mr. Johnson expressed his need for support from pastors in promoting this formation program with youth ministers. The average age of youth ministers is 27. There is a false assumption that Youth Ministry requires young youth ministers to reach junior and senior high students, but there are many "mature" youth ministers who are doing a fine job in parishes.

Future plans are to offer formation training for the volunteer coordinators of youth ministry. Half of all parishes in the Archdiocese have volunteer youth ministers; the other half has either full- or part-time employees.

There is a need to offer formation of "core teams" in youth ministry. They don't need the full certification but they do need the foundation of youth ministry that comes from the USCCB's document *Renewing the Vision: A Framework For Catholic Youth Ministry*. This is the foundation for all youth ministry throughout the U.S. and is used in Canada and Australia as well.

The Office of Youth Ministry is more than willing to assist pastors in the hiring process of Youth Ministers. Mr. Johnson and his staff can be a valuable resource for parishes as they make the important decisions to hire a Youth Minister. Pastors are encouraged to talk to one another when a Youth Minister is moving from one parish to the next. Pastors are asked and urged to consult with the Youth Office before hiring a new Youth Minister.

The Office of Youth Ministry, working with the CCE Office, wants to be more visible and present to parishes. They are working on a framework for curriculum for Catholic high schools and parish catechetical programs. The Youth Office is working toward a scope that encompasses kindergarten through adulthood. A great youth program comes from great adult formation. The OYM developed a 2007 document entitled "Blueprint" aimed at helping the parishes that have never had a youth program start one from scratch.

Mr. Johnson presented a document that details goals, strategies and tactics planned through 2013 with respect to the following areas: Prayer & Liturgy, Evangelization & Lifelong Faith Formation, Pastoral Care, Social Justice, Clergy Support, Staff Development, Formation of Youth Ministry Leaders, and Leadership Formation of Youth. The Office of Youth Ministry in the Archdiocese is nationally recognized and serves as a reference point for other dioceses in regards to their own programs. The Office has been approached about hosting the 2013 National Youth Conference as it did several years ago.

The Council thanked Mr. Johnson and his staff for his dedicated work on behalf of the youth and Youth Ministers of the Archdiocese. Priests and pastors are exhorted to take an active role in supporting youth ministry activities in their parishes, and to use the Office of Youth Ministry as resource for ministering to and with students.

<u>CONSULTATION AND ANNOUNCEMENTS:</u> Cardinal DiNardo asked for feedback on the responses that were received in parishes after the homilies of the weekend of July 4 concerning immigration reform. Cardinal indicated he had received about 25 letters at the Chancery, three of which were positive. Council members offered comments reflecting reactions received from parishioners. While there was some negative feedback, the pastors reported they also received support and commendation for tackling an important social justice issue.

Cardinal DiNardo also announced that former judge Frank Rynd has been hired as the new legal counsel for the Archdiocese replacing the retired John Sieger.

AGENDA ITEMS: Future topics include the new Archdiocesan website and a review of Archdiocesan directory, an update on the Pastoral Plan, and planning for the implementation of the new translation of the Roman Missal.

<u>CLOSING PRAYER</u>: Cardinal DiNardo offered the closing prayer at approximately 12 noon.

# Liturgical Calendar Advisory: Feast of Our Lady of Guadalupe, Solemnity of the Nativity of the Lord, and Solemnity of Mary, Mother of God

#### **December 12, 2010**

The date assigned in the liturgical calendar for the celebration of the Feast of Our Lady of Guadalupe is December 12. This year the feast falls on the Third Sunday in Advent. Because —"Sunday must be ranked as the first holyday of all" (General Norms for the Liturgical Year and the Calendar [GNLYC], no. 4; see Sacrosanctum Concilium, art. 106), it gives way only to solemnities or feasts of the Lord. "The Sundays of the season of Advent, Lent, and Easter... take precedence over all solemnities and feast of the Lord" (GNLYC, no. 5). On Sunday, December 12, 2010, only the texts and readings of the Third Sunday of Advent (Year A) may be used.

While safeguarding an integral celebration of Sunday and the Season of Advent, the prescribed prayers and readings are echoed by Our Lady of Guadalupe in many ways. The prophet Isaiah preaches hope and consolation, prophesying the day of salvation for those in need. Jesus is the manifestation and fulfillment of this prophecy, which he points out to the disciples of John the Baptist. Our Lady of Guadalupe claimed justice for the people of Tepeyac, raising up those who were oppressed. On Gaudete Sunday, the Liturgy invites us to "[r]ejoice in the Lord always" (Entrance Antiphon). Our Blessed Lady fittingly shows how to rejoice in God our Savior, for her entire life was a hymn of praise.

While observing the Third Sunday of Advent, attention may be given to Our Lady of Guadalupe. The placement of her image in the liturgical space can call attention to this celebration. Intentions in the Prayer of the Faithful may appropriately include themes reflecting concern for unity in the Americas and may conclude with the collect customarily used for the Mass of Our Lady of Guadalupe. Processions in honor of Our Lady may take place as well. Many other local traditions, including the re-enactment of the story of the apparitions of Our Lady of Guadalupe outside the liturgy may also enhance the celebration of the last week of the Advent season.

In those places where the Feast of Our Lady of Guadalupe has very special significance, the liturgical celebration may be transferred to Saturday, December 11 or Monday, December 13. This is in accord with the General Instruction of the Roman Missal which states, "In cases of serious need or pastoral advantage, at the direction of the diocesan Bishop or with his permission, an appropriate Mass may be celebrated on any day except solemnities, the Sundays of Advent, Lent, and Easter, days within the Octave of Easter, the Commemoration of All the Faithful Departed (All Souls' Day), Ash Wednesday, and Holy Week" (no. 374).

#### December 25, 2010

Also in 2010 the Nativity of the Lord (Christmas) falls on a Saturday. Christmas retains the precept and should be observed as a Holy Day of Obligation. Christmas is not affected by the NCCB decision referenced below (see Holy Days of Obligation). The Feast of the Holy Family of Jesus, Mary, and Joseph follows on Sunday, December 26, 2010. Because Christmas is a day of obligation, no ritual Masses, including weddings or funerals, may be celebrated (GIRM, no. 372). Since most marriages in the United States are celebrated on Saturdays, pastors should take care to avoid scheduling weddings on this date.

The Solemnity of the Nativity of the Lord begins with Evening Prayer I on Friday, December 24, and concludes with the celebration of Evening Prayer II of the Solemnity on December 25. If Mass is celebrated on the evening of Friday, December 24, the Mass is that of the vigil of the Solemnity of the Nativity of the Lord. If Mass is celebrated on Saturday evening, December 25, the Mass is that of the Holy Family of Jesus, Mary, and Joseph.

#### January 1, 2011

The Solemnity of the Blessed Virgin Mary, Mother of God, falls on Saturday, January 1 in the year 2011. In accord with the NCCB decision of November 1991 (see Holy Days of Obligations below), confirmed by the Apostolic See in July 1992, the precept to attend Mass on this day is abrogated. Since the obligation to attend Mass is abrogated, the funeral Mass may be celebrated on this day. <sup>1</sup>

<sup>&</sup>lt;sup>1</sup> GIRM 380. Among the Masses for the Dead, the Funeral Mass holds first place. It may be celebrated on any day except for solemnities that are holy days of obligation, Holy Thursday, the Easter Triduum, and the Sundays of Advent, Lent, and Easter, with due regard also for all the other requirements of the norm of the law.

January 1, however, remains a solemnity and other ritual Masses are forbidden on this day. Since most marriages in the United States are celebrated on Saturdays, pastors should take care in scheduling weddings on this date. While the ritual Mass is forbidden on the Solemnity of the Blessed Virgin Mary, Mother of God, the Mass of the day with the Nuptial Blessing may be celebrated and one of the readings may be taken from the Rite of Marriage. The Rite of Marriage Outside Mass may also be celebrated.

The Solemnity of the Blessed Virgin Mary, Mother of God begins with Evening Prayer I on Friday, December 31, and concludes with mid-day prayer on Saturday. Evening Prayer I of the Epiphany of the Lord takes precedence (General Norms for the Liturgical Year and the Calendar, no. 61). The Liturgy of the Hours on Sunday, January 2, is that of the Epiphany of the Lord. When Mass is celebrated on the evening of Friday, December 31, the Mass is that of the Solemnity of the Blessed Virgin Mary, Mother of God. If Mass is celebrated on Saturday evening, January 1, the Mass is that of the Epiphany of the Lord.

<sup>&</sup>lt;sup>2</sup> GIRM 372. Ritual Masses are connected to the celebration of certain Sacraments or Sacramentals. They are prohibited on Sundays of Advent, Lent, and Easter, on solemnities, on the days within the Octave of Easter, on the Commemoration of All the Faithful Departed (All Souls' Day), on Ash Wednesday, and during Holy Week, taking due account of the norms given in the ritual books or in the Masses themselves
