HOLY DAYS OF OBLIGATION

Reminder: On a back to back occurrence of Sunday and Holy Day there is a precept of Eucharist participation for each day. However, whenever January 1 (Solemnity of Mary, Mother of God), or August 15 (Solemnity of the Assumption), or November 1 (Solemnity of All Saints) falls on a Saturday or on a Monday, the precept to attend Mass is abrogated, however, at least one Mass for the Solemnity is still to be celebrated.

This does not apply to December 8, (Feast of the Immaculate Conception) or December 25 (Christmas).

RETIRED PRIESTS



Minutes Meeting of October 5, 2010

The Council met in the Board Room of the Nold Education Building at St. Mary's Seminary. Cardinal Daniel DiNardo presided. Fr. Sean Horrigan called the meeting to order at 10 a.m. Fr. Sean Horrigan offered the Opening Prayer that had been prepared by Fr. Eric Pitre. Fr. Paul Felix took the roll.

MINUTES: The minutes of August 3, 2010 were accepted as presented. Msgr. Borski moved the acceptance of the minutes and Fr. Patout seconded it. They were accepted by a voice vote.

<u>ELECTIONS</u>: Fr. Horrigan indicated those completing terms on the Presbyteral Council are the following: Fr. Dwight Canizares, Fr. Rivers Patout, Fr. Ron Cloutier, all of who are eligible for re-election. Appointees finishing terms are Msgr. Leo Wleczyk and Fr. Wencil Pavlovsky.

The Personnel Board positions to be filled include the position for those ordained 25 years and over, non associates, – vacated by the late Fr. Hubert Kealy, and those ordained 0-15 years, non-associates, vacated by Fr. Clint Ressler who has surpassed 15 years of priestly ministry.

Fr. Brendan Cahill and Fr. Albert Zanatta volunteered to assist Fr. Horrigan on the election committee.

ARCHDIOCESAN WEBSITE AND DIRECTORY: Ms. Jenny Faber, Director of the Archdiocesan Secretariat for Communications, presented to the Council a preview of the upcoming new Archdiocesan website. In addition she sought input on the annual printed Archdiocesan directory.

Ms. Faber said the goal of the re-design of the website includes making the site more user-friendly, better branding of the Archdiocesan message with a cohesive look and feel, and to reduce costs for the chancery. The new website will include a new look that will be consistent on all pages. Content management will be easier to manage in-house and can be updated frequently. There will be multiple points of entry to make getting pertinent information quicker and easier for users.

In regards to the Archdiocesan directory, the cost to produce the bound copy directory is \$15.11 per unit (a total cost of \$71,000) compared to the price of the electronic version on a CD at \$3.20 a copy. In an effort to exercise good stewardship the Secretariat is looking at how to reduce costs by reducing the number of books printed and distributed, reducing the page count (removing just four pages could reduce the cost by \$1,575), as well as other cost-saving options. Ms. Faber discussed a survey that was sent through the deaneries to determine a realistic idea of how many hard copies of the directory are actually needed in parishes and how many CD versions would be used.

On behalf of the Council, Msgr. Rossi thanked Ms. Faber and her staff for the improvements they have made in the Secretariat for Communications. A discussion followed in which numerous questions and suggestions were made regarding the directory and the website. The new website is expected to debut in early 2011. Continued efforts will be made to reduce the size and printing costs of the directory.

INTRODUCTION OF THE NEW GENERAL COUNSEL AND DIRECTOR OF HUMAN RESOURCES:

Msgr. Sheltz introduced Frank Rynd to the Pastoral Council as the new General Counsel of the Archdiocese. Mr. Rynd comes to the Archdiocese after serving as a judge for about 12 years and worked 17 years as the General Counsel for the Houston Sports Association. Mr. Rynd said that the office is busy at the moment and he is still learning the many needs of the Archdiocese, but that he and Sara Romero, associate counsel, are there to help priests and parishes in any legal needs.

Michele Yanta is the new Director of Human Resources. She has 30 years of corporate experience in HR. Ms. Yanta said that working in the Church is different from corporate America but that she wants to bring in "best practices" from her corporate experience. Ms. Yanta is working to implement changes and new programs established by her predecessor.

Cardinal DiNardo told the Council that Mr. Rynd is encountering a "baptism by fire" with numerous issues the archdiocese is facing. He encouraged all pastors to work closely with the Human Resources department, saying that many problems can be avoided by close communication with the professional staff in the office of Human Resources.

Msgr. Rossi raised the concern that the Legal and Human Resources departments get calls from both pastors and their staffs. This can sometimes undermine trust between pastors and the Human Resources office. Ms. Yanta responded that open communication between the Human Resources Department is very important. Msgr. Rossi explained that if an employee calls the Human Resources department there could develop a possible triangulation that can complicate a given situation. There is a need for pastors to have confidence that the Human Resources office will communicate freely and effectively with the pastors.

It was further noted that those working in Catholic schools should first contact the Archdiocesan Schools office about procedures before engaging either the Legal or HR offices. Often such questions can best be addressed in the Catholic Schools office without immediately involving the downtown Chancery.

Fr. Horrigan invited Ms. Yanta to return to the Council in the spring to provide an update on cost-saving initiatives taken this past year in the area of health care and employee benefits.

ARCHDIOCESAN PASTORAL PLAN UPDATE: Msgr. Sheltz updated the Council on the Archdiocesan Pastoral Council (APC) and the Comprehensive Pastoral Planning Process (PPP) that is under development at the Cardinal's request. Members of the APC will visit with all pastors in the Archdiocese to discuss the work of the APC and the plans for the Pastoral Plan of the Archdiocese.

Msgr. Sheltz said that pastors are asked to accommodate the request for a meeting from the APC representatives. This will help foster communication evenly across the archdiocese. It is hoped these meetings with pastors will be completed by December 2010 so as to move forward with pastoral planning in the coming year. Cardinal DiNardo said it would also be important for pastors to be "on board" so as to enable the process of pastoral planning for the archdiocese. The letter to pastors has already been sent out and Cardinal asked that parochial vicars be included in the visit with the APC members.

IMPLEMENTATION OF THE NEW TRANSLATION OF THE ROMAN MISSAL: In the absence of David Wood and Fr. Jomes Burkart, who were both attending a national meeting, Fr. Harrigan offered a summary from the Office of Worship on archdiocesan plans for the implementation of the new translation of the Roman Missal.

Cardinal DiNardo said the new translation is not yet in the hands of the publishers who need a year to get the Missal published and distributed. He said there would be workshops Jan. 12 and 13 at the Charismatic Center for all priests to review the new translation and learn how to best implement in the parishes. Cardinal said that some will

want to utilize video cameras for their practice of the translation and enable priests to review the way they conduct themselves in the liturgy. There are a number of resources on line, and more are coming each day. Cardinal DiNardo indicated he didn't want us to "peak too early" in our preparations but that we want to be ready for November 2011. He indicated that we will need to review the GIRM to be ready for the changes in the Mass. He added that, no matter what, the new translation will slow everyone down, which may be good, because of the linguistic style of the texts.

Fr. Horrigan inquired about the use of chant at masses celebrated in the Archdiocese. While Cardinal DiNardo said he encourages priests to chant, it would not be a requirement. He said that Sundays and solemnities should have some chant in the celebrations.

Msgr. Scheel asked whether there were plans to publish a Spanish Missal for use in the U.S. Cardinal DiNardo responded yes, in the future, but that there may need to be some immediate preparation of Spanish-speaking parishioners so they can understand the changes they encounter when attending English language masses.

ANNOUNCEMENTS/CONSULTATIONS:

Cardinal DiNardo announced there is a new organ in the Co-Cathedral of the Sacred Heart.

Pope Benedict XVI, on the Vigil of the 1st Sunday of Advent, will celebrate a *Vigil for Nascent Human Life*, and has asked that all bishops and priests celebrate simultaneously with him. The USCCB is preparing options on how parishes can conduct the vigil service, and the Office of Worship will send materials to aid in the celebration. Though it is Thanksgiving weekend, Cardinal DiNardo requests that all parishes in the Archdiocese offer a service in communion with the Holy Father's wishes..

Msgr. Scheel informed the Pastoral Council of an annual raffle conducted by Catholic Life Insurance. Catholic schools' students sell tickets and the schools are allowed to keep 100% of the funds from the tickets sold. The raffle offers \$40,000 in prizes.

Cardinal said two issues in the upcoming City of Houston elections could have a significant impact on the Archdiocese. The first is in regards to historical landmarks. If a parish or church facility is declared a landmark or in a historical district, limits are imposed with respect to what can be done with the buildings. The Archdiocese is talking to the City of Houston secting exemption. The second is an amendment concerning wate dranage infrastructure. This proposal would likely cause a significant charge of taxes (i.e., a "rain tax") that would be imposed on church-owned real estate. The Archdiocese wants to be good citizens but is in talks with the city in hopes of a compromise.
