MISSIONARY COOPERATIVE PLAN

Please recall that each parish and mission is required to accept the missionary assigned every year by the Mission Office, through the Missionary Cooperative Plan. You will be receiving your assigned missionary for 2011 via a letter from the Mission Office within the next few weeks. The missionary is to talk at the Masses and take up a collection. The parish is to send the money to the Accounting Office at the Chancery for forwarding to the missionary society/diocese.

This mission appeal does not replace the World Mission Sunday second collection in October. Please avoid assigning the missionary on the second-to-last weekend in October.

No parish is required to accept other missionaries to make appeals at the parish during the year. In fact, great caution should be used before agreeing to allow missionaries to make an appeal, as they can have a negative effect on the success of the Missionary Cooperative Plan if parishioners feel they are asked too often to contribute to Before another missionary endeavors. missionary is allowed to make an appeal at the parish, a suitability letter from his superior must be sent to the Chancellor's office for approval and the collection is NOT to be given directly to the missionary.



Some of these organizations are not legitimate, have a checkered past and/or will inundate your parishioners with additional and repeated appeals for donations. Exercise caution as to whom you invite to your parish to make an appeal or presentation. Any special concerns should be brought to the attention of Hilda Ochoa, director of the Mission Office.

CATHOLIC FAITH IN ACTION ADVOCACY DAY - APRIL 6, 2011

Please mark your calendars for the upcoming Catholic Faith in Action Advocacy Day being sponsored by the Texas Catholic Conference on Wednesday, April 6, 2011, in Austin, Texas. Advocacy Day will begin with a rally on the steps of the State Capitol followed by meetings with individual lawmakers to educate them on the Texas Bishops' legislative priorities. Since the Texas Legislature meets only every 2 years, it is an important opportunity for Catholics from around the State of Texas to come together in Austin during the 2011 legislative session to voice our concerns in the areas of life and family life, education, immigration, health and human services and criminal justice reform.

In February, the Archdiocese held two Advocacy Day Training sessions for those individuals interested in participating as part of a team to meet with the legislators. There will be two additional training sessions in March. While all are encouraged to attend the workshops to learn more about the issues, the sessions are designed to prepare the faithful to participate in Catholic Advocacy Day in Austin on April 6. The March training dates are as follows: Tuesday, March 1, 2011, from 6:30-9:00 p.m. at the Catholic Charities' Mamie George Community Center in Richmond and Saturday, March 26, at the Auditorium at St. Dominic Center from 9:00-12:00 noon. To: All Pastors My brother priests:

The Catholic Relief Services Collection (CRS) scheduled for April 2-3, 2011, helps fund Catholic organizations that share in the Catholic mission of promoting the sacredness of human life and the dignity of the human person. In many ways, families are the heart of our communities. When families are in distress, are separated, or are otherwise challenged, our Church reaches out. Ant it does so whether those families are across the street or halfway around the globe.

For example, the Catholic Legal Immigration Network, Inc. (CLINIC) program called National Pro Bono Project for Children matches unaccompanied immigrant children with legal service providers. These children are the most vulnerable migrants: they are usually without resources and are forced to navigate complex legal proceedings without representation. As another example, the Department of Migration and Refugee Services (MRS) of the USCCB provides coordination, training, funding, and monitoring to experts who provide specialized assistance to victims of human trafficking in the U.S. And in its initial response to the earthquakes in Haiti, Catholic Relief Services (CRS) distributed food to nearly 900,000 people. Currently, CRS is providing food to more than 90,000 students in more than 270 schools, as well as monthly food rations to more than 100 orphanages and child care centers in Port-au-Prince.

CLINIC, MRS and CRS are just three of the six worldwide Catholic relief agencies funded by the Catholic Relief Services Collection. The other agencies are the USCCB Department of Justice. Peace and Human Development (JPHD), the USCCB Secretariat of Cultural Diversity in the Church and the Holy Father's Relief Fund. Each of these agencies provides vital assistance, from pastoral support to humanitarian aid, all over the world. The work being supported through the Catholic Relief Services Collection prioritizes family by protecting children, fighting for family reunification. and supporting the life and dignity of each human person.



The Council met in the Board Room of the Nold Education Building at St. Mary's Seminary, Cardinal Daniel DiNardo presided, fr. Sean Horrigan called the meeting to order at 10 a.m. Msgr. Chester Borski offered the Opening Prayer, Fr. Paul Felix took the roll

MINUTES: The minutes of October 5, 2010 were accepted as presented. Fr. Lahart moved the acceptance of the minutes and Fr. Zanatta seconded it. They were accepted by a voice vote.

ELECTIONS: Msgr. Sheltz announced the results of the recent elections for the Presbyteral Council and Personnel Board, Fr. Bruce Noble (Chaplain Corps), Fr. Dwight Canizares (Eastern and San Jacinto deancries), and Fr. Rivers Patout (Bay Area and Southeast deaneries) were elected to the Prosbyteral Council, Fr. Charlie Samperi (0-15) years ordained) and Msgr. Bill Young (25+ years ordained, non-associate) were elected to the Personnel Board.

FINANCIAL UPDATES: Mr. David Hessel, Chief Financial Officer, and Ms. Michele Yanta, Director of Human Resources, presented a draft of the Financial Statement that has been approved by the Archdiocesan Finance Council. The statement reports there was only one audit adjustment. There were no recommended improvements in internal controls at this time. The nearly \$7.6 million deficit is primarily related to pensions. Mr. Hessel and Ms. Yanta, along with their colleagues, are working on improving that situation. When the draft is finalized it will be posted on the archdiocesan website.

In regards to pension deficit (something that is being seen in both non-profit and for-profit companies across the country). Mr. Hessel said his office plans to conduct a detailed review of pension billings this year to all parishes, schools, and other archdiocesan entities. These institutions will be sent a letter indicating the difference between the Human Resources Office's calculations of pensions and what the parishes have actually paid. This will be done working off of calendar year 2010. The letter will be an attempt to "true up" accounts and work out any necessary adjustments. It was noted by the Cardinal that schools have more problems in this regard. Mr. Hessel said the focus has been the pension in general, and that over the last 10-11 years the market has been down resulting in the deficits.

Mr. Hessel and Ms. Yanta are consulting other dioceses for possible solutions. Our postemployment unfunded liability is \$83 million from \$71 million last year based on the average life expectancy. The Chancery is looking at possibly moving away from a defined benefits plan to an enhanced 403B.

Cardinal DiNardo expressed concern that anything the archdiocese does to the pension be "right and just" for the employees who came to work for the Church because of our benefits. Ms. Yanta told the Council that the key stakeholders are teachers. They look to us to be on par with school districts.

Mr. Hessel said that only 43 parishes have qualified for the insurance discount/rebate incentive offered to those that meet certain disaster preparation requirements. An additional offer will be made to parishes that have yet to qualify with a proposed deadline of April 30, 2011. This initiative is aimed at minimizing exposure to hurricane damages.

The medical health insurance plan has been running a deficit for several years, while the business insurance plan has been profitable. A review is underway that could help square-up the balance.

The Chancery Program Review Task Force is looking at all 160 programs offered by the archdiocese to determine if there are ways to reduce costs and duplication of services. A letter has been sent to pastors asking for input by January 1, 2011. This will be helpful in establishing next year's budget. Pastors are asked to submit their review, even if the deadline has passed. They will be sorted by deanery and Deans will provide feedback to the taskforce. The task force will make recommendations to the Cardinal.

PREPARATION FOR THE NEW TRANSLATION OF THE ROMAN MISSAL: David Wood, from the Office of Worship, discussed the media effort to prepare for the implementation of the new English translation of the Missal. The Archdiocesan website is being utilized to provide resources including an assembly card that can be printed out and used in church. There will be videos discussing the various changes including one of Cardinal DiNardo. The website will have bulletin articles along with a variety of publications that can be used in parishes. There is an effort to keep these materials as affordable as possible.

Cardinal emphasized that priests should be able to give theological background for the changes in the texts. One example would be the change to ("pro multis") "for many" as opposed to the "for all" as is said in the current translation. Cardinal will write about such changes in his Texas Catholic Herald column.

Some special materials will go out in Spanish so as to make the Spanish-speaking will be aware of the changes as well, but it was noted that a new Spanish missal is several years in future.

There will be a gathering of priests on January 12 and 13 to begin the effort to aid priests in getting ready for preparing the faithful for the new translation. Additionally, there will be four meetings of deaneries providing sessions to aid priests in the implementation. It was noted that the Eucharistic Prayers are on the USCCB website for those who want to begin practicing now.

In addition, Mr. Wood provided a review of the upcoming formation for the laity. There will be regional meetings provided for parish implementation teams. All parishes should send a team to one of the meetings to gather ideas how to best form the faithful for the upcoming changes. Also, the Office of Worship is preparing recommendations for new musical settings for Mass. Some composers are modifying existing Mass settings while others are writing entirely new settings for Mass. GIA Publishing is preparing a new Worship 4 hymnal as well.

PROPOSED SCHEDULE FOR EFFECTIVE PASTORS SEMINAR: Fr. Horrigan distributed the proposed schedule for the upcoming Effective Pastors Seminar to be held February 22-24 at Holy Name Retreat Center. It will be primarily for those priests who have been named Pastor within the last two years. Cardinal DiNardo noted that men who are named Pastor for the first time are reminded to evaluate their new assignment carefully and resist making changes in the first year.

<u>ANNOUNCEMENTS/CONSULTATIONS</u>: The Advent/Christmas evening prayer and dinner for priests is approaching and all priests are encouraged to attend.

A number of international priests will be coming into the Archdiocese in early 2011. They will attend the International Priest Acculturation Program (IPAP) to learn about the local Church and the culture. If needed, they will also be asked to attend accent reduction classes. Members of the local presbyterate are asked to make the new international priests welcome in the archdiocese.

There is a Syro-Malankar church that was located in Rosharon and now is in Missouri City. They have an Eparchy here in the U.S. Local parishes need to be aware of their presence with regard to marriages.

Syriac Catholics (from Iraq) are also in the archdiocese and are looking for a facility. Anyone who knows of an available building is requested to let the Chancery know.

Cardinal DiNardo reiterated that all priests are to be good shepherds of their own souls. Any priests experiencing difficulty or personal issues are encouraged to reach out to Fr. Italo Dell'Oro, the Minister to Priests, for assistance. Fr. Italo is prepared to serve both diocesan and religious order priest in need of spiritual and emotional help. Cardinal DiNardo encouraged all priests to pray daily for their brother priests who are ill, suffering or experiencing difficulty.


