### 2011 DATES FOR PRIESTS TO RESERVE

### TRANSFERRING DIOCESAN PRIESTS

The diocesan Accountable Reimbursement Plan allows diocesan priests to reimbursed up to \$1,500 per calendar year for business related expenses identified in the plan. All diocesan priests who have recently transferred parishes should have their parish bookkeeper prepare a statement showing how much of the ARP for 2010 has already been used. This should be given to the parish to which the priest is transferred so that the bookkeeper will know that the priest is only to be reimbursed for the unused portion of the ARP for 2010.

### HOLY DAYS OF OBLIGATION

On back to back occurrence of Sunday and Holy Days, there is a precept of Eucharist participation for each day. However, whenever January 1, the Solemnity of Mary, Mother of God, or August 15, the Solemnity of the Assumption, or November 1, the Solemnity of All Saints, falls on a Saturday or on a Monday, the precept to attend Mass is abrogated (NCCB, 11/17/92, Congregation for Bishops, While the Holy day obligation is 7/4/92). automatically abrogated on these days, the liturgy of the feast is still to be celebrated in every parish and institution at a convenient time in such a way that the dignity of the feast is maintained.

### MARRIAGES OUTSIDE THE ARCHDIOCESE

When parishes are preparing couples for a marriage that will take place outside the Archdiocese of Galveston-Houston, please be sure to send the completed marriage packet to the chancellor's office approximately one-month before the scheduled wedding date. This is necessary so that the Archdiocese can issue a nihil obstat on the preparation materials and provide a letter granting permission for the couple to be married outside the archdiocese.

To avoid delay, carefully review marriage packets to ensure that all documents are properly executed, signed and that current baptismal certificates issued within 6 months and affidavits of free status (2 each for the bride and groom) are included. A letter from the pastor of the couple to the pastor of the parish where the wedding will take place granting permission for the couple to be married outside the jurisdiction of the parish must also be included.

Some (Arch)dioceses will not allow the wedding to take place if these permission letters are not included in the marriage packet.

## MANDATORY VIRTUS REFRESHER TRAINING FOR CLERGY

Any priests who attended the VIRTUS Protecting God's Children Workshop between 2003-2005 are required to attend a new mandatory refresher program, VIRTUS Keeping the Promise Alive. Please see the attached letter from Cardinal DiNardo for additional information.

## TESTAMENTARY GIFTS TO YOUR PARISH OR SCHOOL

Some estate challenges can be avoided with a simple review of the documents, and the Legal Department can help make sure the decedent's wishes are correctly carried out.

If a parishioner requests information on including your parish or school in their estate, provide them with the following language for their legal advisor.

My Brother Priest:

At the very heart of Christianity is faith in Jesus Christ, a faith that bears fruit in love. We are to love the poor, the hungry, the thirsty, the naked, the ill, the stranger and the prisoner. Under these tough times, poverty affects more and more individuals and families in our communities. There is an ever increasing need for the work of people who clearly see the Face of God in each suffering, hungry, homeless, abandoned and less fortunate person. We have an ever-increasing need for the work of the Society of St. Vincent de Paul in our Archdiocese. Our faith reminds us that we are all in these crises together and calls on us to respond to such oppression.

The work of the Society of St. Vincent de Paul has been and is truly a wonderful response to God's poor. We have been blessed with this organization's Catholic lay volunteers that minister to the poor, sick, elderly and less fortunate. In 2010, 435,000 direct aid services were offered to individuals in need through our Archdiocese. The Society provided \$5.9 million in assistance with food, clothing, household needs, as well as financial help for rent, utilities, transportation, medications and funeral expenses. In their despair the less fortunate of our brothers and sisters found hope through the efforts of the men and women of the Society.

The annual Society of St. Vincent de Paul Archdiocesan Council Black Bag Collection is scheduled for the weekend of July 16-17. The theme of this year is "Planting Seeds of Hope: Changing the face of Poverty, one Person at a time." This is the only major collection for the Society's Archdiocesan Council during the year and I ask for your active assistance in encouraging your parishioners to support this very important and most needed ministry.

The funds collected in this annual Black Bag Collection will enable the Archdiocesan Council to provide assistance to those in need throughout our Archdiocese. Assistance is provided through programs such as the Home Visit Ministry, the Food Network, the Vincentian Uplift Program that helps to prevent homelessness, and the St. Vincent de Paul Resale Store Ministry that offers clothing, furniture and household goods at no charge to those in need.

The work of the Society is dependent on the committed efforts of over 1800 Vincentian volunteers. They cannot effectively provide the needed services without financial support. Your parishioners become essential partners in the Vincentian work when they contribute to the Annual Black Bag Collection. The Society needs this support and I encourage you to promote this gift from the pulpit. "It is from your hands that Our Lord in the person of the hungry, homeless and sick seeks relief." St. Vincent de Paul, Patron, Society of St. Vincent de Paul.

I encourage you, or a parishioner from your parish ministry of St. Vincent de Paul, to make this plea on behalf of the poor. Through you and your parish the work of the Society of St. Vincent de Paul can continue.

My brother priests:

The annual Infirm Priests' Collection is a major source of revenue through which the Archdiocese is able to provide much needed medical and emergency support for our retired and infirm priests. This year the Infirm Priests' Collection will be the weekend of August 13-14.

As you are very well aware, medical costs continue to rise at an ever-increasing rate. These escalating costs can become very burdensome for our brother priests, especially those who are retired and have a limited income. These priests dedicated their active ministry years to the tireless care of the faithful of this Archdiocese. It is now our turn to provide them with our best care and support.

We are blessed to have an increased number of priests joining our Archdiocese through ordination or incardination. Still, over one-third of our archdiocesan priests are over 65 years of age and we presently have 57 priests living in retirement. The Archdiocese will face even greater financial responsibilities as more priests reach retirement age or face serious illness. Therefore, I ask you to please encourage your parishioners to generously support the Infirm Priests' Collection.

In parishes staffed by religious order priests, it is the practice of the Archdiocese that one-half of the Infirm Priests' Collection be provided to the religious order to be applied to the medical insurance premiums of the priests. Parishes are to send the entire collection to the chancery. The chancellor will forward to the superior the religious order's share of the collection.

I am deeply grateful for your pastoral zeal and priestly ministry. The faithful of this Archdiocese are well served by a devoted presbyterate. I thank you for encouraging your parishioners to be generous in their support of our retired and infirm priests and for their fervent prayers for an increase in vocations to the priesthood and religious life.

Dear Brother Priests.

One of the commitments made by the U.S. Bishops when we approved the "Charter for the Protection of Children and Young People" in late 2002, was that we would implement programs in our respective dioceses to help ensure that there would be no further victims of sexual abuse of minors by clergy or other Church personnel. In fulfillment of that commitment, the Archdiocese of Galveston-Houston announced in February 2003 its plans to implement the *VIRTUS Protecting God's Children for Adults* program. Over the course of these last 8 years, approximately 73,152 priests, deacons, employees, volunteers and parents have been trained on the issue of child sexual abuse awareness and prevention through this program.

At last week's meeting of the U.S. Bishops, we as a body voted to renew and approve a revised Charter which brings it in line with the most recent Vatican instructions in this area. This is an ideal time for the Archdiocese of Galveston-Houston to also renew our commitment to creating a safe environment for children and youth through the implementation of a refresher training course, VIRTUS Keeping the Promise Alive. The refresher training is a brief 1½ hour training program designed to remind you of the warning signs of child sexual abuse and the prevention tools you previously learned during the original 3 hour VIRTUS Protecting God's Children workshop.

During this initial phase of the refresher training program, we are focusing our efforts on priests, deacons and Catholic school teachers who first attended the VIRTUS Protecting God's Children Workshop from 2003-2005. All active priests, deacons and teachers who attended the workshop during that period are expected to attend this mandatory refresher training a condition of continued ministry and/or employment in this Archdiocese.

We have scheduled four *VIRTUS Keeping the Promise Alive* workshops for priests <u>only</u> and they will be held in the Auditorium of the Nold Education Center at St. Mary Seminary on the following days:

If you attended the VIRTUS *Protecting God's Children* workshop between 2003-2005, you will receive an email communication from the VIRTUS online system in the next few days providing instructions for registering for the above referenced VIRTUS *Keeping the Promise Alive* workshop. Please follow the prompts. If you do not receive an email from the VIRTUS online system in early July regarding the refresher training, please contact Isabel Guerra in the Safe Environment office at 713-652-8298 or <a href="mailto:iguerra@archgh.org">iguerra@archgh.org</a>.

In January 2012, we will begin the second phase of refresher implementation which will target our other parish employees and volunteers who attended the original workshop between 2003-2005. Please note the new refresher training program is not intended to be a substitute for the 3 hour *VIRTUS Protecting God's Children Workshop*. All new clergy, employees and volunteers having regular contact with children and youth are still required to attend the VIRTUS *Protecting God's Children Workshop* as an introductory training on these important issues. These individuals will be asked to attend a refresher course at a much later date.

I look forward to seeing you at one of the priests training sessions at St. Mary Seminary. If you are unable to attend <u>one</u> of the workshops for priests, please inform Msgr. George Sheltz, prior to <u>July 31, 2011</u>.

Thank you for all of your efforts in ensuring that we are creating a safe environment for our children and youth.

## IMPORTANT NOTICE FOR PRIESTS WHO ARE NON-U.S. CITIZENS AND WILL BE CHANGING ASSIGNMENTS

TO:

Non-U.S. citizen priests

FROM:

The Department of Homeland Security: Citizenship and Immigration Services (former INS) has many new rules and regulations for non-U.S. citizens who are legally in this country. One such rule requires all non-U.S. citizens to report a change of address within 10 days of the address change by use of Form AR-11. A person who fails to do this is subject to criminal penalties and removal from the United States.

If you have recently moved and have not done so already, please complete the enclosed form and send it to the Office of Homeland Security. Due to the threat of terrorism, the Office is very strict in enforcing immigration laws. Failure to comply with all immigration regulations could jeopardize a priest's ability to remain in the United States. I would suggest that the form be mailed with a delivery confirmation receipt so that the priest will have a record that the form arrived at the U.S. Department of Homeland Security.
