MISSIONARY COOPERATIVE PLAN

Please recall that each parish and mission is required to accept the missionary assigned every year by the Mission Office through the Missionary Cooperative Plan. The missionary is to talk at the Masses and take up a collection. The parish is to send the money to the Mission Office at the chancery for forwarding to the missionary society/diocese.

Please try to avoid World Mission Sunday, which is the second-to-last weekend in October, when assigning the missionary.

No parish is required to accept other missionaries to make appeals at the parish during the year. In fact, great caution should be before agreeing to allow missionaries to make an appeal, as they can have a negative effect on the success of the Missionary Cooperative Plan if parishioners feel they are asked too often to contribute to missionary endeavors. If another missionary is allowed to make an appeal, the collection is NOT to be given directly to the missionary. The money should be sent to the Mission Office in the chancery for forwarding to the missionary society/diocese.

Please be aware that some organizations not linked directly to the Church might aggressively approach you requesting to make a presentation or mission appeal during the weekend, while offering a priest to help you with the celebration of Mass. Some of these organizations have a checkered past and/or will inundate your parishioners with additional and excessive appeals for donations. Exercise caution as to whom you invite to your parish to make and appeal or presentation. Any special concerns should be brought to the attention of Hilda Ochoa, director of the Mission Office.



PRESBYTERAL COUNCIL

Archdiocese of Galveston-Houston

Minutes
Meeting of June 7, 2011

The Council met in the Board Room of the Nold Education Building at St. Mary's Seminary. Cardinal Daniel DiNardo presided. Fr. Sean Horrigan called the meeting to order at 10 a.m. Msgr. Dan Scheel offered the Opening Prayer. Fr. Paul Felix took the roll.

MINUTES: The minutes of April 19, 2011 were accepted as presented. Fr. Lahart moved the acceptance of the minutes and Msgr. Scheel seconded it. They were accepted by a voice vote.

ARCHDIOCESAN PASTORAL PLAN UPDATE: Mr. Jim Barrette, Secretariat Director of Pastoral and Educational Ministries, updated the Council on the archdiocesan pastoral planning process. Mr. Barrette reported that the input is good and seems consistent between the data gained in surveys and listening sessions. In response to a question, Mr. Barrette said that the overall purpose of this planning process is to generate recommendations to the Cardinal for pathways for parish structures.

Mr. Barrette presented the Executive Summary of the study conducted by The Center for Applied Research in the Apostolate (CARA). The study provides a projection of the availability of priests from the years 2010 through 2040. If current trends continue, it appears that we will be able to hold our own in terms of the number of priests available for ministry going forward. However, the study did not take into account the projected increase in population for our part of the country. The study revealed that we had elevated number of priests who are not currently in active ministry. The study will be discussed in greater detail at the vicariate meetings for priests. Those meetings will also take up the archdiocesan pastoral planning process.

Fr. Horrigan asked about the "Safe and Sacred" program. It was reiterated that this entails having one lesson plan per Religious Education class in every grade in the parish RE programs by December of this year. The CCE office is coordinating the plans with local DREs.

JUST WAGE SCALE FOR WOMEN RELIGIOUS: Sr. Heloise Cruzat, O.P., the Vicar for Religious, returned with a follow-up presentation of the draft letter concerning the recommended salary structure for religious sisters and brothers in the Archdiocese. The draft letter was reviewed and suggestions were made for editorial changes. The final letter will be published stating that this recommended salary structure will be implemented in fiscal year budget beginning 2012.

<u>FY 2011-12 BUDGET:</u> Mr. David Hessel, Chief Financial Officer, addressed the Council with the budget preparations for the fiscal year 2011 - 2012. He stated that the process of preparing the budget is becoming more simplified. He made the following points in his presentation:

- 1. budget assumptions
- 2. the disaster recovery fund now has \$5 million accrued
- 3. the health insurance program is operating at a loss and will require some revisions
- 4. discussed the diocesan Savings and Loan budget
- 5. St. Mary's Seminary budget is close to breaking even
- 6. the Chancery is operating at a loss of \$354,000
- 7. he reminded the Council that the pension fund has a significant unfunded liability and will require additional work to remedy that situation.

Cardinal DiNardo noted that the review of diocesan offices and programs continues to ensure that all Chancery departments are operating as efficiently as possible and with minimal duplication of services.

Fr. Lahart made the motion that the Council recommended to the Cardinal that the proposed budget be approved. Msgr. Scheel seconded the motion and it was unanimously approved.

<u>ANNOUNCEMENTS/CONSULTATIONS</u>: Cardinal DiNardo announced Auxiliary Bishop Emeritus Vincent M. Rizzotto will turn 80 in September. Priests are encouraged to send personal greetings. A future celebration of is planned, perhaps at the annual Christmas party.

The Cardinal requested input on the proposal of a fixed date for Diocesan Services Fund (DSF) Commitment Sunday each year. The Council approved the first Sunday in February.

Cardinal DiNardo said he will be in Seattle for the summer Bishops' meeting. They will be reviewing the charter for the handling of accusations of sexual abuse. The USCCB

Respect Life Committee is preparing a statement on euthanasia. The Cardinal will be in Rome for the Pallium Mass in late June and some other matters.

<u>AGENDA ITEMS</u>: Review of benefits for retired priests, review of News Media policy, and review of Emergency Contact system.

CLOSING PRAYER: Cardinal DiNardo led the Council in the concluding prayer.

Who Needs to Take Virtus?



Earlier this month, many of our Archdiocesan priests and deacons attended the Virtus Keeping the Promise Alive course at St. Mary's Seminary for those who took the original Protecting God's Children course in the years 2003-2005. At the refresher session Cardinal DiNardo and Msgr. George Sheltz expanded the list of ministers that are required to be Virtus certified. Additional ministries have been added to the list due to the experience of the past 8 years that Virtus has been offered in our Archdiocese. The people in the following parish/school ministries are required to complete Virtus:

- ➤ All parish/school employees and contract employees
- ➤ Volunteer directors/coordinators of religious education
- > Religious education catechists and staff
- > Volunteers in youth ministry programs, including Life Teen, e.g., regular drivers
- > Volunteers in parochial and diocesan schools
- > Coaches or volunteers in athletic programs
- > Volunteers in quinceaneras preparation
- Scout Leaders (Boy Scouts, Cub Scouts, Girl Scouts, etc.)
- > Volunteers with children and youth choirs
- Volunteers in an early childhood center/program
- ➤ Volunteers in Mother's Day Out programs
- > Volunteers in a parish nursery
- Volunteer coordinators/trainers of altar servers
- > Volunteers that include an overnight stay, e.g., retreats, lock-ins, away from the child/youth's
- > Volunteers in Children's Liturgy of the Word programs
- > Liturgical ministers (lectors, ushers, EMEs, acolytes, choirs, wedding coordinators)
- Food Pantry volunteers where families with children are served
- > Volunteers in any other public ministry which carries with it an "implied trust"

The term "implied trust" means that this person, due to the performance of their ministry, would be considered by the parishioners to be a "safe and trusted" person or leader of the church due to the function of their ministry.

The concepts presented in the Virtus programs have been highly successful in helping the faithful to recognize possible child predators in their parish communities. Over the past 8 years, the reporting of their concerns has led to investigations by the safe environment and legal department resulting in the removal of 200 offenders from parish ministry and tagging them in a "no volunteer" status in our Virtus database. With your continued vigilance our precious children and youth will continue to be protected. Please make sure that your parish/school Safe Environment coordinator checks the Virtus status of all your volunteers in the Virtus data base before they volunteer to make sure they are in an "active" profile.

Recently, a parish in the Archdiocese was the victim of electronic bank fraud. All our parishes and other operations are vulnerable to this type of crime as more of our transactions occur using electronic means. While many of these schemes are very sophisticated and hard to guard against, there are certain basic precautions that can be taken to dramatically reduce the risk of electronic bank fraud. They are summarized below:

General Computer Safety Techniques:

- 1) Use good antivirus software and keep it up to date (note that free antivirus software is generally insufficient - a recognized brand such as Norton or McAfee are good choices). Consider having it set to scan attachments on incoming e-mail.
- 2) Install software security patches (i.e.: Windows, Adobe Acrobat, Java, etc). Numerous patches are issued on a continuous basis to help thwart hackers. These need to be installed when available.
- 3) Parish networks should use firewalls (preferably a hardware based firewall) networks that are not behind a firewall are usually quickly infected with computer viruses.
- 4) Secure the internet browsers used by your employees on parish computers the maximum possible/practical security settings should be used. The use of JAVA applets should be restricted to only trusted sites.
- 5) E-mail safety do not open any e-mail you do not recognize or seems suspicious even if from a person or entity you know. E-mails are the main method used to initiate phishing attacks (where the hacker attempts to get you to give them user names and passwords) and to deliver viruses (in either an attachment or in the body of the e-mail). If in doubt - and even if the e-mail appears to come from a recognized source - call the sender before you open it. Remember, government agencies like the IRS or institutions such as your bank will never send you an e-mail asking for your personal information. Beware of any attachment (especially executable files ending in .exe) or web page link on suspicious e-mails. Clicking on them could activate a virus.
- 6) Keep logon IDs and passwords secure. Each user must have their own. DO NOT share them (ever). Do not keep them in your desk, on a post-it note stuck to your monitor, or written on your desk blotter.

- 7) Always lock your computer when you step away from it (this can be accomplished through the ctrl-alt-del command and then choosing the lock option)
- 8) Change your password regularly make it alphanumeric and not easy to guess.
- 9) Log off and turn off your computer at the end of the work day.

General Bank Account Safety:

- 1) All new account documentation should be reviewed by the Legal Department (this includes basic account agreements, online banking agreements, ACH agreements, wire transfer agreements) and should be kept on file.
- 2) For written checks, positive pay (a service where checks that are about to clear are compared to a check run that you send to the bank) should be used if available (especially if your bank, as a matter of policy, will not check signatures).
- 3) Check stock should be on the best possible paper (i.e.: with the highest number of security features), have preprinted numbers and kept in a secure area
- 4) Check account balances and transactions on bank accounts several times per day and always check first thing in the morning and at the end of the business day in the evening.
- 5) Reconcile bank statements monthly.
- 6) Get to know your local banker. Make sure that they understand that you want to hear about any unusual activity on your account.

Electronic Banking Transaction Safety:

- 1) Retail, home banking/bill pay software should not be used this kind of software has inadequate security and is inappropriate to handle parish business. Your bank's commercial cash management/bank portal software is what should be used (it is like the home banking product - but with much more robust security settings and features)
- 2) Periodically have your bank or system administrator print out a list of users and user rights. Make sure that the correct employees have access and the rights set are appropriate to their function.
- 3) Periodically review the audit logs (if available). These should tell you who logged on, when and performed what transactions.
- 4) All bank software used to initiate financial transactions should have adjustable security settings and, if possible, should require the use of a token (either a device that generates a random number, a USB device that plugs into the computer to verify user identity, or at a minimum installs a cookie that recognizes the computer you are using)
 - a. There should be a minimum of two security administrators on any banking system. It should require the approval of both security administrators to change any user rights.
 - b. Security administrators should not be users if possible. If not possible no one security administrator should be able to change their own user rights.
 - c. All wire transfers should require (at a minimum) two users to initiate and release a transfer (large dollar amounts should require three).
 - d. All ACH Templates should require, at a minimum, two users to setup or change a template.

- 5) Debit maximums (individual and daily maximums) should be set on your account (at reasonable levels) and the use of debit blocks are encouraged (you can create exceptions for routine payments). This forces unusual debits to be to be rejected until reviewed and approved by the customer.
- 6) Only activate the services you expect to use. If you offer direct deposit payroll and pay certain vendors electronically, activate ACH functionality but not the wire transfer functionality (in addition, wire transfers are much more expensive). If you only issue manual checks and access electronic banking for balance and transaction information, do not activate any funds transfer abilities.
- 7) Notification functionality should be used if available. On many systems this functionality can be customized to send you email notifications of pending items according to criteria you set. Such notices should be sent to multiple users.
- 8) All bank software should use encrypted connections (minimum 128 bit SSL encryption)
- 9) Consider using a specific, dedicated computer for all online transactions. Such a computer would be set up without e-mail and would not be used to surf the web (you can even limit web site access on that machine to the bank portals you are using).
