MASS STIPENDS

The Bishop's Fund for Latin America Collection is scheduled for the weekend of January 21-22, 2012. Please make the necessary announcement.

FIRST RECONCILIATION

Reminder: Some parishes have taken the of giving certificates for First practice Reconciliation as well as creating a register. The confidentiality of the Sacrament of Penance should always be kept in mind when recordina Reconciliation. First recommended that a parish may record that the requirements for receiving the Sacrament of Reconciliation have been met. If a parish decides to keep a record of those who have completed these requirements, do not send notification to the places of baptism for recording in the sacramental books.

RETIRED PRIESTS

Please remember the retired priests who reside at the Pope John XXIII Priest Retirement Residence, Maloney Hall and the retirement houses of the religious order priests. These men would benefit greatly from the prayers and periodic visits of their brother priests.

BLUE PAY

It is our understanding that a number of parishes and schools use the vendor Blue Pay to process payroll for their employees. We have been notified that some of our locations are experiencing difficulty with Blue Pay. If your parish or school uses Blue Pay for payroll services, please contact the PAS Department at 713-659-5461 for assistance.

2012 Mileage Logs have been mailed to all archdiocesan and extern priests to track their professional miles driven. Please remember to log the automobile odometer reading on January 1, 2012 and then log all professional miles driven throughout the year. Record the odometer reading on December 31, 2012, thus providing the total miles driven for the year. By adding the total number of professional miles driven a ratio of professional versus personal determined can be (e.a. professional, 40% personal). The total amount of car expenses for the year is determined (e.g. depreciation allowance, insurance, gas, repairs, etc.). The percentage of the total expenses that is equal to the percentage of the professional use of the car (60%) is exempt from taxation. The percentage of the car expense equal to the percentage of the personal use of the car (40%) is added to the priest's taxable income.

2011 Mileage Logs must be given to the parish bookkeeper in early January so that the priest's taxable income can be computed. IRS regulations required that the parish keep the log in case of an IRS audit. Failure to provide the bookkeeper with a completed log of business related mileage will result in ALL car expenses being considered personal and the priest will pay tax on the total amount of yearly car expenses, over \$7,000 in additional income. The log is the only proof that the priest has used his car for professional purposes, hence if no log is maintained the IRS does not allow exemption of a portion of car expenses from taxable income.

IRS MILEAGE RATE

Beginning January 1, 2012, the IRS standard mileage rate for 2012 reimbursement for miles driven for professional purposes is 55.5 cents/mile.

VICTIMS ASSISTANCE COORDINATOR

In a continuing effort to provide pastoral care to victims of sexual abuse by clergy or Church personnel, Daniel Cardinal DiNardo would like to remind the faithful of the Archdiocese of the availability of the Victims Assistance Coordinator. Please place a periodic notice in your parish bulletins as follows: "Anyone who has been the victim of sexual abuse by clergy or Church personnel is encouraged to call Sr. Maureen O'Connell, OP at 713.654.5799." Please keep in your daily prayers the healing of victims of abuse and all who suffer in any way.

LAST WILLS

Every archdiocesan priest (incardinated and extern) ministering in the Archdiocese of Galveston-Houston <u>is</u> to have on file in the chancery either a sealed copy of his last will and testament or a note stating where a copy of the will is to be found. Our records indicate that a number of priests do not have this information in their files.

A nightmare of work falls to family members or priest friends if a priest dies without having executed a will and a list of his personal property or if his will cannot be located. Not only is there difficulty in trying to determine the intent of the priest in the disbursing of his personal belongings, but much of his financial holdings can be taken by the state.

Please forward to the Chancellor's office either a copy of your last will and testament in a sealed envelope with your name on it and state that it is your will, or send a note for your file which states where a copy of your will can be found. It is also most helpful to provide a copy of your funeral arrangements, a directive to physician for health care decisions and a durable power of attorney for health care purposes. Having these on file expedites health care decision making if a priest becomes seriously ill or is approaching imminent death.

Re: Recommendation – Salary Structure for Religious Sisters and Brothers

Dear Brother Priests:

Historically, the Archdiocese of Galveston-Houston has published a suggested salary structure for use by pastors as a guide in compensating religious sisters and brothers who were assigned to work in ministry here. This structure also included specific allowances for housing, automobiles, etc. negotiated with the superiors of the religious communities. Recognizing the complexity of negotiating compensation and benefits through a combination of salary and these allowances, a number of years ago the Archdiocese implemented a policy at the Chancery level to provide salaries using the lay employee scale, thereby eliminating specific allowances. This change in policy resulted in salaries which are sufficient for religious communities to provide housing, automobiles, health benefits, pension, etc. for their own members who are employed by the Archdiocese. This approach simplified the process for determining compensation, while ensuring that the Archdiocese budgets appropriately for the position regardless of whether the employee in the role is a religious sister or brother, or a member of the laity.

Since the standardized salary scale for the laity and religious sisters and brothers has been very successful at the Archdiocesan level, it is our recommendation that all of our parishes and schools adopt this policy as well. In standardizing the salary scale, one issue that must be clearly understood is the treatment of health and pension benefits. In the case of a lay employee who is eligible to receive health insurance and pension benefits, the costs of those benefits are paid by the employer on behalf of the lay employee and the individual is covered on the Archdiocesan health and pension plans. In the case of a religious sister or brother employed in a benefits eligible position, the option is to avail of the benefits offered, or have a value placed on the cost of health and pension benefits and that amount is included in the calculation of their overall salary to be paid to their religious community. In the latter case, the order provides this benefit to its members through its own established health and pension plans.

Please be advised you may still need to engage in specific negotiations with the religious superior to address individual circumstances which are unique to members of religious communities: e.g., time off for annual retreats and attendance at community assemblies, recognizing that full time lay employees typically receive two weeks off. If there is a significant disparity between the time off allotted to a lay employee plus an additional two weeks, as needed, for the community obligations of a religious sister or brother in the same position, it would be appropriate to adjust their salary to address this disparity.

It is our recommendation that the salary structure described in this letter become implemented for the 2012-2013 fiscal year. We understand, as do the religious and their congregations, that some parishes have limited ability to advance religious salaries to a lay level. You are encouraged to discuss this as you engage in specific negotiations with the religious superiors. We have every confidence that negotiating conversations will support and encourage the ongoing commitment of our religious who are so aware of the Gospel call to be in solidarity with the poor.

In the Archdiocese of Galveston-Houston, this is an issue of justice in recognition of the significant contribution of women religious to our parishes and schools beginning in 1847 and continuing to the present. If you have any specific concerns or unique circumstances relating to the implementing of a lay salary scale for religious sisters and brothers, please do not hesitate to contact my office.
