- 1. The **Lenten Day of Prayer** for Priests will be on Thursday afternoon, March 29, 2012, beginning at 1:30 p.m. at St. Mary Seminary.
- 2. The **Chrism Mass** will be at 7:00 p.m. on Tuesday, April 3, 2012, at the Co-Cathedral of the Sacred Heart.
- 3. Convocation and Clergy Days will be held from May 7-10, 2012, at the Moody Gardens in Galveston.
- 4. **Priesthood Ordinations** are scheduled for 10:00 a.m. on Saturday, June 2, 2012, at the Co-Cathedral of the Sacred Heart.
- 5. The **Priests' Christmas Party for 2012** is scheduled for <u>Tuesday</u>, December 18. Vespers begin at 5:15 p.m. at the Co-Cathedral of the Sacred Heart followed by a reception at Cathedral Center. Place this date on your calendar and plan on attending. Please do not schedule any penance services for that night.

RETIRED PRIESTS

Please remember the retired priests who reside at the Pope John XXIII Priest Retirement Residence, Maloney Hall and the retirement houses of the religious order priests. These men would benefit greatly from the prayers and periodic visits of their brother priests.

ADULT CONFIRMATION

Parishes are encouraged to have a separate program for adult Catholics seeking to be confirmed. The Adult confirmations will be on the weekend of Pentecost Sunday, May 26-27, 2012, and the weekend of Trinity, June 2-3, 2012. Priests do not have the faculty to confirm an adult unless they are being received into the church (by baptism or profession of faith) at the same ceremony.

The list will also be published on the Chancery Advisory and on the Archdiocesan Website. The Chancery Advisory and Archdiocesan website will be updated weekly.

LAST WILLS

Every archdiocesan priest (incardinated and extern) ministering in the Archdiocese of Galveston-Houston **is** to have on file in the chancery either a sealed copy of his last will and testament or a note stating where a copy of the will is to be found. Our records indicate that a number of priests do not have this information in their files.

A nightmare of work falls to family members or priest friends if a priest dies without having executed a will and a list of his personal property or if his will cannot be located. Not only is there difficulty in trying to determine the intent of the priest in the disbursing of his personal belongings, but much of his financial holdings can be taken by the state.

Please forward to the Chancellor's office either a copy of your last will and testament in a sealed envelope with your name on it and state that it is your will, or send a note for your file which states where a copy of your will can be found. It is also most helpful to provide a copy of your funeral arrangements, a directive to physician for health care decisions and a durable power of attorney for health care purposes. Having these on file expedites health care decision making if a priest becomes seriously ill or is approaching imminent death.



My brother priest:

In the 25th chapter of the Gospel of St. Matthew, Our Lord states very clearly that an essential element of the mission of the Church is to provide the basic necessities of life to our brothers and sisters in their time of need. Clothing the naked, feeding the hungry, visiting the sick and imprisoned and welcoming the alien is required to be a faithful follower of Jesus.

Each parish of the Archdiocese of Galveston-Houston does much to address the needs of the people who live within their area. However, there are many people whose needs cannot be met by the parish alone. For this reason the Archdiocese supports archdiocesan-wide social service agencies tike Catholic Charities, San Jose Clinic and St. Vincent de Paul Society, to name a few. Who Needs to Take Virtus?


Since the publication of the letter that was sent in the Clergy Newsletter of September 2011, it seems further clarification may be needed identifying which ministries are REQUIRED to take VIRTUS training and which ministries we RECOMMEND to complete VIRTUS. The following ministries are required to complete VIRTUS:

- ➤ All parish/school employees and contract employees
- > Volunteer directors/coordinators of religious education
- > Religious education catechists and staff
- ➤ Volunteers in youth ministry programs, including Life Teen, e.g., regular drivers
- > Volunteers in parochial and diocesan schools
- > Coaches or volunteers in athletic programs
- > Volunteers in quinceaneras preparation
- Scout Leaders (Boy Scouts, Cub Scouts, Girl Scouts, etc.)
- Volunteers with children and youth choirs
- Volunteers in an early childhood center/program
- ➤ Volunteers in Mother's Day Out programs
- ➤ Volunteers in a parish nursery
- Volunteer coordinators/trainers of altar servers
- > Volunteers that include an overnight stay, e.g., retreats, lock-ins, away from the child/youth's
- > Volunteers in Children's Liturgy of the Word programs
- > Instituted Acolytes
- > St. Vincent de Paul sponsored food pantries

Participants in other ministries are recommended to complete Virtus if, in the course of their ministry, they come into contact with children/youth. We understand that each parish is unique and it is up to the discretion of the pastor to make this determination. Such ministries would be:

- Liturgical ministers (lectors, ushers, EMHC's, acolytes/servers, choirs, wedding coordinators)
- > Food Pantry volunteers (other than SVDP) where families with children are served
- > Volunteers in any other public ministry which carries with it an "implied trust"

The term "implied trust" means that this person, due to the performance of their ministry, would be considered by the parishioners to be a "safe and trusted" person or leader of the church due to the function of their ministry.



PRESBYTERAL COUNCIL

Archdiocese of Galveston-Houston

Minutes Meeting of December 6, 2011

The Council met in the Board Room of the Nold Education Building at St. Mary's Seminary. Cardinal Daniel DiNardo presided. Fr. Sean Horrigan called the meeting to order at 10 a.m. Father Joe Gietl offered the Opening Prayer. Fr. Paul Felix took the roll.

MINUTES: The minutes of October 4, 2011, were accepted as presented. Fr. Lahart, S.J. moved the acceptance of the minutes and Msgr. Rossi seconded it. They were accepted by a voice vote.

PRESBYTERAL COUNCIL/PERSONNEL BOARD ELECTION RESULTS: Fr. Horrigan presented the results of the recent election for Presbyteral Council and Personnel Board. Elected to the Presbyteral Council were Fr. Miguel Solarzano (Central and Northeast deaneries), Fr. Clint Ressler (Southwest and Northwest deaneries), and Fr. Lahart, S.J. (Special Ministry, Education). Elected to the Personnel Board were Fr. Bart Reynolds (16-25 years ordained, non-associate representative) and Fr. Patrick Garrett (associate representative).

ARCHDIOCESAN TRIBUNAL REVIEW: Fr. Lawrence Jozwiak, Judicial Vicar, presented an overview of the operation of the Metropolitan Tribunal. Over the past five years the Tribunal has averaged 558 cases received in a given year. All of the forms for the various types of petitions have been revised and rewritten and those forms have been adopted for use in many other dioceses across Texas and the country. The Tribunal office is challenged by the lack of Canon lawyers available for work, both priests and laity. It is actively looking to find new canonists to assist the office in its workload.

On average a Formal Case in our archdiocese can be completed in approximately 10-11 months, but all decisions must be sent, per Canon Law, to an Appellate Court. The

Appellate Court of Texas is located in San Antonio and reviews cases from Galveston-Houston and other dioceses, but it has been without a Judicial Vicar for over a year and has been operating with only one full-time judge for some time. This has stretched the average waiting time for an appellate decision to nearly five months. It is hoped that a new Judicial Vicar will be found soon to lead the Appellate Court and that its staffing level will be increased. If that happens it is expected that the waiting time for an appellate decision will be greatly reduced.

In addition to processing petitions, the Tribunal is involved in a great deal of teaching in the archdiocese for candidates for the permanent diaconate and their wives, seminarians and other lay graduate students. It also offers Nullity Case Sponsor training on a regular basis (a new class, the seventh time it has been offered, will be held in the first quarter of 2012). Those who complete Nullity Case Sponsor training are able to assist pastors in meeting with individuals who wish to petition for a declaration of nullity in the parish. Priests are encouraged to send parishioners for such training.

Fr. Jozwiak said the Tribunal is seeking to add up to five new permanent deacons to assist in the office. It is also active seeking new graduates of accredited Canon Law programs to come to Houston for work but there is a scarcity of people entering the profession. The archdiocese currently has one seminarian in Rome who is pursuing a Canon Law degree. Cardinal DiNardo and the Personnel Board are weighing the possibility of sending a priest to pursue further studies in Canon Law as well but the needs of the archdiocese are many.

The Council thanked Fr. Jozwiak and his staff for their work professionalism and dedication in processing the great number of petitions for nullity as well as the other canonical duties of the office.

NCEA 2013 CONVENTION: Sr. Kevina Keating, CCVI, Superintendent of Catholic Schools, informed the council the archdiocese will host the National Catholic Education Association (NCEA) convention April 2-4, 2013, during Easter week. This is the first time the convention will takes place in Texas. It serves as a conference for Catholic schools, clergy, Religious Education teacher and youth leaders as well as Catholic colleges and universities and seminaries.

Archdiocesan institutions are encouraged to promote the convention and make budgetary plans and calendar planning adjustment in order to attend. As this is the major annual Catholic educational conference in the country it is expected that there will be upwards of 8,500 people in attendance. Cardinal DiNardo will be celebrant and homilist for the opening liturgy and Archbishop Garcia-Siller of San Antonio will preside at the closing liturgy.

ST. DOMINIC VILLAGE AND POPE JOHN XXIII PRIESTS RETIREMENT RESIDENCE: Mr. Steve Reiter, CEO of St. Dominic Village, accompanied by Ms. Ruth Stanley, COO, and Deacon Ken Martin appeared before the Council to report on St. Dominic Village and Pope John XXIII Priest Retirement Residence. Mr. Reiter

introduced a pilot program entitled "Adopt a Room" in which parishes or schools or other groups within the archdiocese would be invited to make a commitment to adopt a specific room and its residents at St. Dominic Village. This would be primarily a resident visitation program in which the participants would be asked for a commitment to provide human and spiritual care for the residence in an adopted room.

There are currently 131 residents in the 144-resident capacity nursing home. Twenty-two percent of the residents have no family or no family in the Houston area to look after their needs, and 73 percent have outlived their personal resources and are on Medicaid, and thus are allowed to keep only \$60 a month from Social Security for personal items (clothing, personal grooming, etc.). Adopting parishes would be asked to help provide a level of care for the residents as well as visits and personal interaction. The Council supported the Adopt a Room program and encouraged the St. Dominic Village representatives to develop an orientation program for parishes to learn the process.

Deacon Martin said the Pope John XXIII Priest Retirement Residence offers different levels of care and service to retired priests and continues to take on new residents, however it can often take up to two months for priests to settle in and start feeling at home. The existing facilities are aging rapidly and need significant upgrades to accommodate the future needs of the archdiocese for its retired priests. There is a particular need for a memory care unit for priests and there is also a need to help priests plan and prepare for retirement regarding their health needs and financial needs.

Msgr. Rossi suggested the establishment of a task force to look at the issues and plan for the needs of the future. The Council agreed that a committee should be formed immediately to begin a thorough evaluation of the present and future needs of the Pope John XXIII facility. Cardinal DiNardo agreed and asked the Chancellor to begin look at possibilities in the coming new year. The Council extended its deepest appreciation to Deacon Martin for his dedicated work on behalf of the retired priests of the archdiocese and pledged its support to see that needs of those in their retirement years are addressed in a timely manner.

INDIVIDUAL AND FAMILY RETREATS: Msgr. Sheltz informed the Council that there is a group of lay people who want to promote retreat participation in the archdiocese. After some discussion it was suggested that they establish a central website in which all the various retreat movements and retreat centers could participate. Cardinal DiNardo said that they could place links on the archdiocesan website. Msgr. Sheltz suggested that they could approach the pastors and priests at deanery meetings.

<u>ANNOUNCEMENTS/CONSULTATIONS</u>: Fr. Horrigan reminded the Council members that information was sent out on the Chancery advisory concerning the ongoing pastoral planning process, including bulletin blurbs and intercessions. Parishes are encouraged to promote awareness of the Pastoral Plan.

Msgr. Sheltz announced that the Diocesan Services Fund goal for 2011 has been met and exceeded. Cardinal DiNardo thanked the priests for their support of the DSF.

Cardinal DiNardo had several announcements including:

- 1. The publication of the Confirmation schedule has been delayed as he awaits notice from the Holy See on the dates for the *ad limina* visits of the bishops from Region X. Parish will be notified of Confirmation dates as soon as the travel schedule is finalized.
- 2. The annual Advent Vespers and Christmas party for priests is Dec. 15. Bishop Rizzotto will be honored in recognition of his recent 80th birthday.
- 3. Auditors have stated that the archdiocese is in full compliance with the Charter for the Protection of Children and Youth.
- 4. The religious order Miles Christi has requested permission to conduct retreats in the archdiocese. The request is under consideration at this time.

<u>CLOSING PRAYER</u>: Cardinal DiNardo led the Council in the concluding prayer, followed by an Advent lunch in his residence.


