Effective Fiscal Year 2013 (July 1, 2012-June 30, 2013) the salary of a religious sister/brother is according to the lay employee scale; (ref.: Chancellor's letter of January 1, 2012)

Pastors employing sisters or brothers who are *new* to the archdiocese are asked to have them register with the Vicar for Religious: 713-741-8733; hcruzat@archgh.org.

This information is needed for the database, the directory and for communication purposes. A statement from the major superior granting permission to minister in the archdiocese will be requested for the files.

If the religious is a member of an institute not already present in the archdiocese, the first step should be: invitation by the archbishop to the major superior of the institute and to the local ordinary with appropriate responses.

SUMMER REPLACEMENT PRIEST - PLAN EARLY

If you plan a vacation from June to late August, please begin now to look for priests to cover your Masses.

Though priests are responsible for finding their own replacements, if the visiting priest is without faculties in this Archdiocese, he must be approved for ministry from the Chancellor. The visiting priest must provide a recent letter from his bishop or religious superior stating that he is a priest in good standing and has permission to be in the Archdiocese.

In addition, please be advised that if you wish to invite a foreign national priest who is not a permanent resident of the United States, you must consult with the Chancellor's Office to ensure that the foreign national priest has authorization to work in the U.S. This consultation should occur in advance of extending the invitation.



Minutes Meeting of April 17, 2012

The Council met in the third floor conference room of the Nold Building at St. Mary Seminary. Fr. Rivers Patout called the meeting to order at 10:00 a.m. Fr. Clint Ressler offered the Opening Prayer. Fr. Paul Felix took the roll.

MINUTES: The minutes of February 21, 2012 were accepted as presented. They were

<u>UPDATE OF EPISCOPAL ORDINATION</u>: Christina Deajon, Vice Chancellor and Roz Hill, Director of Development updated the Council on the preparations for the Episcopal ordination Bishop-elect Msgr. George Sheltz. They reported on the number of RSVPs received to date as well as the events that are scheduled:

- ❖ Tuesday, May 1, 2012: 6 PM Vespers at the Co-Cathedral of the Sacred Heart with Bishop-elect Sheltz presiding. Followed by 7 PM dinner at the Four Seasons Hotel, 1600 Lamar. This event is by invitation only. Priests and visiting Bishops are invited along with Bishop − elect Sheltz's family members.
- ❖ Wednesday, May 2, 2012: 11 AM luncheon at the Cathedral Centre. By invitation only: visiting bishops, family members and special guests.
- ❖ Ordination of Bishop Sheltz 2 PM 4:30 PM. Seats are reserved for Bishops, Pastors, Priests and Deacons who have RSVP'd. Other guests are admitted only with a ticket. Each ticket admits one person.

They informed the Council of the special edition of the Catholic Herald and said that they are attempting to set up for streaming video over the internet that would provide, among other things a teaching opportunity to our Catholic schools.

The City of Houston and the Houston Police department are doing us the favor of blocking the street so as to enable the Priests to cross over from the Cathedral Centre to the Co-Cathedral.

EXPLANATION OF BENEFITS TO NEW PRIESTS: Fr. Brendan Cahill, Secretary for Clergy Formation and Chaplaincy Services, presented a draft on a proposed modification to the policy regarding Priest compensation. This is in an effort to clarify questions concerning how uch vacation time and Accountable Reimbursement Plan (ARP) funds are available to newly ordained and newly arrived Priests. It would bring consistency if Priests' vacation time was tracked on a fiscal year basis (July 1 through June 30), as in the case of lay employees. The ARP is tracked on a calendar year basis because it is a part of the IRS code.

Priests newly assigned to the Archdiocese: Newly ordained and newly arrived Priests to the Archdiocese are eligible for two weeks vacation after they have completed six months of ministry in a canonical assignment. After they complete one full year, they then enjoy one month vacation a year (Pastoral Manual C,V,B), on a fiscal year basis (July 1 – June 30).

Archdiocesan/extern priests (ARP is only for priests who pay taxes): During the calendar year (January - December) in which the Priest begins his canonical ministry in the Archdiocese, the Priest can utilize his accountable reimbursement plan on a prorated basis. For example, if the Priest begins ministry in January, he has a 12/12 of \$1500 = \$1500. If the Priest begins ministry in June he has 6/12 of \$1500 = \$750.

The Presbyteral Council recommended this modification to be adopted as policy through a voice vote with no objections.

<u>REVISION OF DEANERY COMPOSITION:</u> Fr. Clint Ressler addressed the Council asking input on the topic of revising the deanery structure as a part of the pastoral planning process. Fr. Ressler and Fr. Bob Barras are collaborating on this effort. One of the goals is to arrive at smaller geographic groupings. One question is whether the groupings should be geographic or more based on demographic, ethnic, cultural, etc.

There was considerable input on this topic. Some of the comments offered are as follows:

- > Clarify the role of the deanery vs role of the vicariate.
- > Consider what clustering makes sense.
- > Look at how the DRE's and Deacons gatherings are doing in relation to, or in comparison with the Priests.
- > Take a survey in order to see what parish relationships already exist.
- ➤ Look at demographic data that has been utilized by the Archdiocesan Pastoral Council.
- > The map of parish boundaries needs to be updated.

Fr. Ressler thanked the Council for its input. He & Fr. Barras will go to work on a draft and then return to the Council for review.

<u>BUDGET PROCESS FOR 2012-2013:</u> Mr. David Hessel, Archdiocesan Finance Officer and Business Manager, addressed the Council on the budget process that is currently underway.

He indicated that from April 18-20, 2012, the Cardinal's cabinet would be working on the fiscal year 2012-13 budget. The Finance Council will review the proposed budget and give their input on May 31 and then it will be presented to the Presbyteral Council at their June 5 meeting.

Challenges include the Health plan and the estimated deficit for the coming year. They are trying to enhance communication with parishes and institutions: budget assumptions, health plan, etc. Protocol is to communicate with to Pastors, Catholic Schools office to get to school principals and then parish administrative staff. They are working to improve internal communications. The new Internal Audit Director, Margaret Thompson, has produced numerous reports on internal audits. A key theme has to do with effective Finance Councils. There is a direct correlation between the effectiveness of the Finance Council and the length of the Internal Audit report. They are looking at ways to work to train and strengthen Finance Councils.

They are working with parishes to restructure debt, helping them to save money.

He hopes we are taking advantage of the 16% rate decrease for Reliant customers. This is a onetime decrease and then it will be static for three years.

The question was raised as to whether there was a way the Archdiocese could bid out more services and products to enable us to get better rates. Mr. Hessel replied in the affirmative. This is an area that could be further developed.

Margaret Thompson, Vicki Stroman and David Hessel are able to give deanery level workshops.

Bishop – elect Sheltz commented that most audits revealing difficulties show the lack of adequate financial controls and the strength of the Finance Council.

Cardinal DiNardo said that financial transparency is the up and coming issue for the Church in the U.S. It is important that we have this in place for our parishes, both diocesan and religious. Financial transparency is very important for the Church's credibility. The Cardinal is asking that we talk about this on the deanery level.

<u>POLICY FOR PAYING FOR PRIESTS'S FUNERAL</u>: Fr. Paul Felix presented a topic raised by Fr. John Kappe, a priest of the Archdiocese, who says that Archdiocesan Priests are giving their lives to the Church. He thinks the Archdiocese should pay for the cost of Priests' funerals. There was also a question about where the funds go from the life

insurance policy that is taken out on each priest. Msgr Rossi replied that the Archdiocese provides a burial plot at our Catholic cemeteries, liner for the grave, opening and closing expenses, a head stone. Priests and their families are responsible for their own coffin and any other additional expenses such as limousines, burial at some place other than a Catholic Cemetery in the Archdiocese, etc.

There are two insurance policies taken out on archdiocesan Priests. One goes to benefit the Infirmed Priests' Fund and the second policy goes to the estate of the Priest so as to aid in covering the Priests' funeral expenses in the amount of \$3000.

The information on what is provided by the Archdiocese is located in the Archdiocesan Pastoral Manual and the Manual for Retiring Priests.

The point was made that numerous priests are lacking wills, funeral arrangements indicating what they want to have for their funeral, Durable Power of Attorney for Health Care.

One comment was made that some priests need some coaching to fill out the forms. Human Resources Dept and the Legal Dept could be of help in preparing those documents.

<u>ANNOUNCEMENTS/CONSULTATIONS</u> Cardinal DiNardo Informed the Council that he sent a message congratulating the Holy Father on his 85th birthday and his 7th anniversary of elevation to the Petrine ministry. Cardinal described his recent *ad limina* visit to pray at the tombs of the apostles Peter and Paul and to meet the Holy Father and the dicasteries of the Roman curia.

The discussion moved into the difficulty we are facing regarding the Obama administration's HHS rules. He emphasized the fact that this is a serious issue and so we can't overreact. Statements over the top are not helpful. We have to be consistent in pressing the message

<u>LUNCH</u>: Cardinal DiNardo led the Council in the prayer before lunch: The Lord's Prayer for Pope Benedict and the blessing of the meal.

ARCHDIOCESAN PASTORAL COUNCIL: Mr. Jim Barrette, Director of Pastoral and Educational Ministries, and Mrs. Rita Gonzalez, Chair of the Archdiocesan Pastoral Council(APC), presented to the Council on the progress of the Archdiocesan Pastoral Planning Process. This entails listening so as to sum up the current reality and the development of the desired future. This requires development of pathways.

Mr. Barrette presented a document entitled "Comprehensive Pastoral Plan: Toward a Spirituality of Communion – Proposed Pathways." The emphasis has to be on starting from a spirituality of Communion as called for by Blessed Pope John Paul II, in his apostolic letter "Novo Millennio Ineunte."

The Pathways are as Follows: Live our Faith, Share our Faith and Nurture our Faith.

From the Spirituality of Communion we move into the implementation of action plans, tracking progress, and finally reviewing and revising action plans. This process will take several years.

The implementation development will involve a series of steps:

- Parish Assessments
- * Regional Meetings of Parishes
- Integration Meeting
- Publish Archdiocesan Pastoral Plan
- Parish Action Plans
- Chancery Staff Action Plans

The APC will be distributing materials to parishes as an effort to keep the faithful informed of the process and developments.

They discussed the effort to obtain one delegate to the APC from each parish. They are urging prompt responses from parishes naming delegates. New APC members will be discerned from the deanery groupings of delegates. Time is running short to meet the deadlines.

Mr. Barrette and Mrs. Gonzalez were thanked for the work of the Archdiocesan Pastoral Council and the meeting was concluded.

CLOSING PRAYER: Fr. Patout led the Council in the concluding prayer.


