SUMMER REPLACEMENT PRIEST - PLAN EARLY

If you plan a vacation from June to late August, please begin now to look for priests to cover your Masses.

Though priests are responsible for finding their own replacements, if the visiting priest is without faculties in this Archdiocese, he must be approved for ministry by the Chancellor. The visiting priest must provide a recent letter from his bishop or religious superior stating that he is a priest in good standing and has permission to be in the Archdiocese.

If the priest is a foreign national, he must have the proper authorization to work in the United States.

ADULT CONFIRMATION

Parishes are encouraged to have a separate program for adult Catholics seeking to be confirmed. The Adult confirmations will be on the weekend of Pentecost Sunday, May 18-19, 2013. Priests do not have the faculty to confirm an adult unless they are being received into the church (by baptism or profession of faith) at the same ceremony.

Pugin, from Miami, Florida will be presiding at the services. They include an Anointing Mass, First Communions, and Baptisms.

MISSIONARY COOPERATIVE PLAN

Please recall that each parish and mission is required to accept the missionary assigned every year by the Mission Office, through the Missionary Cooperative Plan. You will be receiving your assigned missionary for 2011 via a letter from the Mission Office within the next few weeks. The missionary is to talk at the Masses and take up a collection. The parish is to send the money to the Accounting Office at the Chancery for forwarding to the missionary society/diocese.

This mission appeal does not replace the World Mission Sunday second collection in October. Please avoid assigning the missionary on the second-to-last weekend in October.

No parish is required to accept other missionaries to make appeals at the parish during the year. In fact, great caution should be used before agreeing to allow missionaries to make an appeal, as they can have a negative effect on the success of the Missionary Cooperative Plan if parishioners feel they are asked too often to contribute to missionary endeavors. Before another missionary is allowed to make an appeal at the parish, a suitability letter from his superior must be sent to the Chancellor's office for approval and the collection is NOT to be given directly to the missionary.

Please be aware that some organizations not linked directly to the Church might aggressively approach you, requesting an invitation to make a presentation or mission appeal during the weekend, while offering a priest to help you with the celebration of the Mass. Some of these organizations are not legitimate, have a checkered past and/or will inundate your parishioners with additional and repeated appeals for donations. Exercise caution as to whom you invite to your parish to make an appeal or presentation. Any special concerns should be brought to the attention of Hilda Ochoa, director of the Mission Office.

EASTER TRIDUUM

Triduum – Holy Saturday and the Easter Vigil

On this day and Holy Saturday, the Church does not celebrate the sacraments at all except for Penance and the Anointing of the Sick (Roman Missal Good Friday #1). The Easter Vigil in the Holy Night, the first Mass of Easter, is celebrated in the night between March 30 and March 31, in 2013. There is to be only one celebration in each church. The law of the Church is that the celebration of the Easter Vigil is celebrated at night.

The General Norms for the Liturgical Year and the Calendar, no. 21, states:

"The Easter Vigil, in the holy night when the Lord rose again, is considered the 'mother of all holy Vigils,' in which the Church, keeping watch, awaits the Resurrection of Christ and celebrates it in the Sacraments. Therefore, the entire celebration of this sacred Vigil must take place at night, so that it both begins after nightfall and ends before the dawn on the Sunday.

Consequently, the Easter Vigil liturgy in 2013 may not begin before 8:30 p.m.

Note changes in the Roman Missal 3rd Edition:

- The preparation of the Paschal Candle is no longer optional although the 5 grains of incense is optional.
- The procession with the Paschal Candle is slightly modified:
 - o Paschal Candle is lit at the fire
 - Procession Order: thurifer, deacon (or other minister) with lighted Paschal Candle, followed by
 - priest and ministers, finally the people (note: no crucifix). All hold unlit taper candles.
 - Deacon\minister lifts the candle and intones "The light of Christ" or "Lumen Christi"
 - at the door to the churchpriest lights taper
 - in the middle of the church — all light their tapers
 - in front of the altar
 - o candle placed in stand
 - all lights are lit except for the altar candles

Re: Resignation of Pope Benedict XVI and Election of the Pope

I want to direct your attention to Spanish and English resources we have placed on the archdiocesan website related to the anticipated resignation of Pope Benedict XVI and the election of the new Pope. The web address is www.archgh.org/conclave.

During this period of transition in the Church, as we await the election of a new Pope, I strongly urge the faithful of the Archdiocese of Galveston-Houston to offer frequent prayers for the Church including prayer for the Cardinals who will discern the next Pope. The custom of praying the Our Father, Hail Mary and Glory Be to the Father is encouraged. I also encourage parishes to celebrate Holy Hours when possible. The liturgy of Exposition of the Eucharist, whenever possible, should begin with the celebration of Mass and is to follow strictly the description of the rite found in the document, Holy Communion and Worship of the Eucharist Outside of Mass. An Order of Worship has been prepared and is found under the Prayer and Liturgy Resources on the Conclave webpage.

The Secretariat of Divine Worship of the USCCB has prepared a very useful resource to assist parishes in their prayer for Pope Benedict XVI and for the Church in anticipation of the election of the next Pope which includes helpful instructions, suggestions, intercessions and musical resources. The web address follows.

Following Pope Benedict XVI's resignation (anticipated for February 28, 1 p.m. Central time):

- The remembrance of the Pope is omitted from the Eucharistic Prayer. However, we continue saying, "with Daniel our Bishop".
 - o Eucharistic Prayer I (The Roman Canon) Be pleased to grant her peace, to guard, unite and govern her throughout the whole world, together with N. our Bishop, and all those who, holding to the truth, hand on the catholic and apostolic faith.

Eucharistic Prayer II

Remember, Lord, your Church, spread throughout the world, and bring her to the fullness of charity, together with N. our Bishop and all the clergy.

Eucharistic Prayer III

May this Sacrifice of our reconciliation, we pray, O Lord, advance the peace and salvation of all the world. Be pleased to confirm in faith and charity your pilgrim Church on earth, with N. our Bishop, the Order of Bishops, all the clergy, and the entire people you have gained for your own.

Eucharistic Prayer for Various Needs I

Lord, renew your Church (which is in N.) by the light of the Gospel.


Strengthen the bond of unity between the faithful and the pastors of your people, together with N. our Bishop, and the whole Order of Bishops, that in a world torn by strife your people may shine forth as a prophetic sign of unity and concord.

- Cardinal DiNardo has given permission to use of the Mass texts "4. For the Election of a Pope or a Bishop" from the "Masses and Prayers for Various Needs and Occasions" on weekdays of Lent. This may not be used on Sundays of Lent, solemnities, feasts or during Holy Week.
- In the Liturgy of the Hours, when there is no obligatory memorial, feast or solemnity, the closing prayer may be taken from the Mass for the Election of a Pope or a Bishop.
- The Election of the Pope should be prayed for in the Rosary.
- Prayer for the election of the Pope should open and/or close all meetings and gatherings.
- An intercession for the election of the Pope is to be included in all Masses. See the USCCB document for examples.
 - That the Holy Spirit will inspire and strengthen the Cardinal-electors as they choose a new Holy Father to lead us, we pray to the Lord.
 - That the College of Cardinals in its electoral process may be a worthy vehicle of God's grace guiding the Church, we pray to the Lord.
 - That the Holy Spirit will work strongly in the next Pope chosen by the College of Cardinals, we pray to the Lord.
- Parishes should prepare gold and white bunting. This is simply white and gold fabric that drapes and/or surrounds the outside entrance to the church.

Upon news of the election of a new Pope:

- White and gold bunting is customarily displayed above the outside entrance to the church.
 Flowers may appropriately be placed near the Vatican flag placed prominently in the narthex.
- I ask that a Mass be celebrated in each parish using the Mass "For the Pope" found in the "Masses and Prayers for Various Needs and Occasions. This Mass may not be celebrated on Sundays, solemnities, feasts or during Holy Week.
- Prayer for the new Pope in the General Intercessions, for example:
 - For our new Holy Father, N., that he may be strengthened as he embarks on his ministry of unity, love and peace, we pray to the Lord.
 - That our recently elected Holy Father, N., working together with the bishops of the Church, may build up the Body of Christ in peace and in joy, we pray to the Lord.
 - That our newly elected Holy Father N. may be a champion of the poor, a reconciler of nations and a force for peace and unity in our world, we pray to the Lord.
- The faithful are encouraged to pray for the new Pope and his intentions by the recitation of the Our Father, Hail Mary and Glory Be to the Father.
- Praying for the Pope in the Rosary is encouraged.

Minutes
Meeting of December 4, 2012

The Council met in the third floor conference room of the Nold Building at St. Mary Seminary. Fr. Rivers Patout called the meeting to order at 10:00 a.m. Fr. Michael Barossa offered the Opening Prayer. Fr. Paul Felix took the roll.

MINUTES: The minutes of October 9, 2012 were accepted as presented. The motion to accept was made by Fr. Lahart and seconded by Fr. Gietl. The motion to accept passed by a voice vote.

PRESBYTERAL COUNCIL/PERSONNEL BOARD ELECTION RESULTS: Fr. Brendan Cahill reported the outcome of the recent election as follows:

<u>ECUMENISM COMMISSION</u>: Fr. Reginald Samuels addressed the Council with an update on the promotion of interfaith, interreligious and ecumenical dialogue in the Archdiocese of Galveston-Houston. He provided three documents:

- A draft letter, for Cardinal DiNardo's approval and signature, for the Week of Prayer for Christian Unity (proposed to be January 18-25, 2013) to be sent out to parishes, along with -
- A list of "Roman Catholic Resources" containing a list of documents and other reading suggestions as well as resource websites.
- Possible Strategic Planning Process for Ecumenical and Interreligious Commission of the Archdiocese of Galveston-Houston.

Cardinal DiNardo made the following comments:

- He suggested naming the commission the Ecumenical and Interfaith (interreligious) Commission.
- He noted the delay of the pro-life march in Washington D.C., due to the presidential inauguration, from the 22nd to the 23rd or 24th of January. On the 19th of January is the annual national observance of Dr. Martin Luther King Day. This seems to be a good date for ecumenical prayer and dialogue.
- He suggested some materials be made available to aid Priests in preparation of homily and other liturgical resources. Cardinal mentioned there are opportunities for interfaith activities are issues based such as human trafficking, etc.

Msgr Borski requested continuing education opportunities to aid in updating in Vatican II (and post Vatican II) documents concerning ecumenical relations in light of the contemporary situation.

There was discussion of the movement away of people from adjudicatories to the independent congregations. This presents a much more difficult situation. Fr. Samuels noted the lack of interest to get together for prayer as opposed to getting together on collaboration over issues. He reported the Holy Father is emphasizing both the effort for uniting in prayer and collaboration.

Cardinal noted that a series on prayer, cultural and theological exchange was proposed by Bishop Reinhardt, the head of the local Evangelical Lutheran Church of America, in observance of the 500th anniversary of the Protestant reformation. He responded in the affirmative but has not heard back. He also noted that from among the Muslims, not the imams, but the laity, are showing interest in discussing and collaborating with us on issues of common interest.

<u>UPDATE ON HISPANIC MINISTRY PROGRAM IN THE ARCHDIOCESE</u>: Fr. Manuel La Rosa-Lopez, Vicar of Hispanic Catholics, and Mr. Sergio Castillo, Director of the Archdiocesan Office of Hispanic Ministry, approached the Council.

Fr. Lopez stated that the Hispanic Priests meet the third Thursday of every month for discussion and a meal. The attendance usually ranges from 15 to 20 Priests. They are discussing a desired vocational plan that is more sensitive to the Hispanic culture. They

want to talk with the Office of Vocations concerning Hispanic vocations. There is a need for a Diaconal formation program in Spanish. There is a need for more Priests and deacons to learn how to speak Spanish. Fr. Manuel informed the Council that the University of St. Thomas has a plan to offer a program for Priests and Deacons to learn the Spanish language.

Msgr. Rossi suggested that Priests who come into the Archdiocese, post ordination, should be required to study Spanish as well.

Fr. Cahill commented that one requirement for international Priests are required to learn English before coming here.

Fr. Manuel suggested representatives of the Archdiocese establish relationships with Bishops in Latin-American dioceses from which Priests could be lent to us for a period of 3-5 years. Immigration laws make it difficult for Priests to come here to minister within the Archdiocese. In light of so many non-catholic "ministries" that are springing up and putting out signs that say "Misa" (Mass), effectively drawing many Hispanic people away from their Catholic religion, it was suggested that we look for a building for a "Macro" (large) church as a center where Spanish speakers can go for Masses - some place situated where there are large concentrations of Spanish speaking people. Concern was expressed that this would be a shrine where people go without any sense of responsibility for the Catholic community.

Msgr. Rossi suggested reviewing Presbyteral Council minutes from 10-12 years ago when Msgr. Pickard was chairing a committee looking for facilities where there could be regional catechetical centers for catechesis and sacramental preparations as well as for quinceaños, etc.

Fr. la Rosa – Lopez said that Shalom Center will begin providing services for Priests and support groups for prevention of problems, etc., in Spanish.

Mr. Sergio Castillo provided a hand-out on the Office of Hispanic Ministry. He highlighted the distinction between the roles of the Hispanic Delegates and those of the Parish Directors/Coordinators of Hispanic ministry who meet with Mr. Castillo on a monthly basis.

He spoke about programs such as leadership development and training for Pastors working with shared parishes for unity.

This was followed with discussion around arranging for Priests to aid in providing for Masses, etc, in Spanish as well as coordination of scheduling Spanish Masses between parishes in various areas of the Archdiocese that would enable Spanish language supply Priests to help in multiple parishes in a given region on the weekends, etc.

IT PLAN/ BUSINESS INSURANCE RATE REDUCTION, HEALTH PLAN PREMIUM INCREASE: David Hessel, Archdiocesan Finance Officer & Business Manager, and Ed Herrera, Director of IT for the Archdiocese, presented on the upcoming changes in technology. Some components of the Logos software are not going to be supported in the future. The IT department is seeking input on selecting a software program for the future. We have about 2.5 years to migrate off the Logos platform to another one. They are asking that a committee be established for finding a good replacement platform that could provide for: Accounting, Census, Facilities Management, Ministries scheduler and Sacramental Registry.

Mr. Hessel spoke about the upcoming Book Keepers meeting conducted by Margaret Thompson to go over issues that are being found repeatedly in the audits of parish and schools.

Mr. Hessel informed the Council of a rate reduction of approximately 26% in property and liability insurance due to the progress made in achieving a 9.5 million dollar fund, established in the wake of hurricane lke, to cover damages from storms, etc. The progress was made through an insurance rate increase and measures taken by the Archdiocese and parishes to minimize our exposure to risk. The reduction will be seen at the beginning of April.

After months of study it is necessary for parishes and schools to plan in their budgets for 2013-14, for an 3% increase in the health pan rates. There will probably be an annual increase going forward.

The upcoming DSF regional meetings in January will be dedicating a portion of the meeting to discussing Risk Management with Pastors.

WORLD APOSTLESHIP OF THE SEA CONGRESS: Cardinal DiNardo reported on the congress that was hosted in Rome and the importance of the ministry provided for the Port of Houston. Houston has a superb reputation for ministry in the world. It is both Catholic and ecumenical. He spoke about the difficulty our homeland security policies and immigration laws present for mariners and their ability to get off the ships at US ports. Among other things, the Holy See is concerned about piracy. Persons staffing cruise ships need pastoral care. 65% of persons working on docks or the sea are Catholic. The Port of Houston is leader in tonnage in the USA. May 22nd is World Mariners' Day.

ANNOUNCEMENTS & CONSULTATIONS: Cardinal DiNardo announced he ordained Bishop Joseph Strickland as the new bishop of Tyler.

A number of dioceses are vacant or will be becoming vacant in the near future: San Angelo, El Paso has been vacant for a year, Las Cruces, New Mexico is also vacant.



The Council convened in the conference room of the Bishop Nold Building at St. Mary Seminary. Fr. Rivers Patout presided and called the meeting to order at 10:00 a.m. Msgr. Fr. Joe Gietl offered the Opening Prayer. Fr. Paul Felix took the roll.

MINUTES: The minutes of December 4, 2012, were read and approved as written.

WELCOME OF NEW MEMBERS: Fr. Patout welcomed returning member Page Polk, OFM (representing Archdiocesan chaplains) and new member Fr. Stephen "Bart" Reynolds (representing Northern/Western/Bluebonnet Deaneries).

<u>ELECTION OF COUNCIL SECRETARY</u>: Fr. Stephen "Bart" Reynolds was elected secretary. The Council thanked Fr. Paul Felix for his recent and dedicated service in this capacity.

ARCHDIOCESAN PASTORAL PLAN: Mr. Jim Barrette, Fr. Pat Garrett, Mrs. Sue Fogerty, and Mrs. Mary Grace Landrum made a presentation on the status of the Archdiocesan Pastoral Plan. Copies of the proposed objectives were distributed to Council members for discussion.

There was a review of the Pastoral Plan timeline, of the work done to date to identify priorities, and a summary of the results of regional meetings. The information gathered throughout the consultations has been distilled into nine objectives. Parishes will be asked to study the objectives and to formulate action plans responding to some or all of them. The numeration of the priorities does not imply a relative ranking among them. They move from the more general to the more specific.

Cardinal DiNardo noted that the priorities may have repercussions for various chancery offices, especially in the areas of education and liturgy. Depending upon the response from parishes, and the plans they formulate, the offices of the Archdiocese will need to respond in a helpful way.

It was further noted that despite the large numbers entering the Church through the R.C.I.A. – Galveston-Houston is second only to Los Angeles among U.S. dioceses – work remains to be done in reaching out to inactive Catholics.

The objective dealing with collaboration between parishes has been a priority among respondents and listening-session participants from the beginning of the planning process. The Cardinal hopes that parishes will take some risks and work with other communities that are different from their own. This may be the objective that has the most life for our people, he noted.

Observations were made about the importance of the use of social media in pastoral planning and in outreach. Different expectations with regard to on-going formation were noted among Anglo participants and all others. Most Anglos saw formal instruction and lectures as essential in adult formation. Others emphasized retreats, pilgrimages, and spiritual formation opportunities.

The process of formulating an Archdiocesan Pastoral Plan has been widely consultative. There is no intention of imposing anything from above. Together with the publication of the objectives, the Council discussed the advisability of producing a brief, one-page introduction to the process to accompany the planned workbook, which will be the primary tool of parishes in their action plans.

As the plan unfolds at the parish level, there will be a concerted effort to share fruits among parishes. The Presbyteral Council was in agreement that the objectives should be published and distributed to pastors.

<u>CORPUS CHRISTI COLLECTION</u>: Fr. Trung Nguyen, Rector of St. Mary Seminary and Fr. Dat Hoang, Director of the Office of Vocations, addressed the Council.

Fr. Nguyen expressed his gratitude to the parishes of the Archdiocese for their financial support of the seminary through the Corpus Christi collection. The seminary depends upon these funds to support her mission in forming seminarians, permanent deacons, and in collaborating with the Ordinariate of the Chair of St. Peter.

There are seventy-five seminarians this year, with the expectation that next year there will be eighty-five or so. The facility was built sixty years ago, and the administration has strengthened the maintenance staff to continue to care for the campus.

Since several dioceses now send candidates to the seminary, there was a discussion on how to successfully invite those dioceses to offer similar support to St. Mary's. This is a matter for the seminary Board to consider, and must be developed over time, Fr. Nguyen noted.

Fr. Nguyen and Fr. Hoang suggested that seminarians participate in the preparations for the Corpus Christi collection by visiting parishes the weekend before (May 25-26), by speaking before or after Mass and thanking the parish for their support. The idea was well received. Council members noted that in efforts to sustain and increase seminary support, it is important to communicate the costs involved in educating and forming seminarians. Fr. Nguyen noted that the current annual expense is approximately \$40,000 per student per year.

THE SEDE VACANTE PERIOD AND THE CONCLAVE: Cardinal DiNardo spoke about the upcoming conclave in Rome. He will leave for Rome on Tuesday, February 26 in order to join the other Cardinals who will meet with the Holy Father on his last day in office. After Pope Benedict's resignation takes effect, the Cardinals will collectively administer the Church until the election of the new Pope.

The Holy See may allow the conclave to take place earlier in March than originally anticipated. The Cardinal hopes that he will return to Houston for Holy Week. He noted that he has purchased a round-trip ticket. In the absence of Cardinal DiNardo, Bishop Sheltz will be responsible for administration.

February 22 is the Feast of the Chair of St. Peter. Priests are encouraged to remember Pope Benedict in a special way on that day. After 8:00 p.m. Rome time on February 28 (1:00 p.m. Central Time), parishes have permission to offer "Mass for the Election of a Pope or Bishop" (Roman Missal, p. 1247). Readings may be of the day, or drawn from those given in the Lectionary (Lectionary, vol. IV, pp. 833ff.). This Mass may only be celebrated on those weekdays of Lent that are not superseded by a liturgical Feast or Solemnity. An Archdiocesan Mass will also be arranged.

Petitions and prayers for the Holy Father (until Feb. 28) and for the Cardinals (from March 1 until the election) are fittingly offered at all parish Masses. Upon the election of a new Pope, bunting (white, gold, or a combination thereof) may be placed around the doors of the parish church. The USCCB website has a number of liturgical resources available. 


