## SUMMER REPLACEMENT PRIEST - PLAN EARLY

If you plan a vacation from June to late August, please begin now to look for priests to cover your Masses.

Though priests are responsible for finding their own replacements, if the visiting priest is without faculties in this Archdiocese, he must be approved for ministry by the Chancellor. The visiting priest must provide a recent letter from his bishop or religious superior stating that he is a priest in good standing and has permission to be in the Archdiocese.

If the priest is a foreign national, he must have the proper authorization to work in the United States.

## GODPARENTS AND TESTIMONIAL LETTERS

To be a sponsor for either Baptism or Confirmation, it is required that the person be a baptized, confirmed and practicing Catholic (c. 872-874). If the sponsor is married, the marriage must be a valid and recognized marriage in the Church. No letter of suitability from the sponsor's parish is required by canon law or diocesan guidelines. If there is concern, the parish may ask the sponsor to sign a letter stating that they meet the requirements and conditions to be a sponsor, but this is not a requirement.

Please inform DRE's, baptismal teams and others that there is no requirement for such letters of testimony from the priest or parish of the Baptism or Confirmation sponsor.



My brother priests:

Lask you to please remind your parishioners of the collection on the Solemnity of Corpus Christi (weekend of June 1-2, 2013) for the support of men studying for the priesthood for our Archdiocese and the religious communities which staff some of our parishes. Your personal appeal for a very generous contribution from each parishioner will help to realize an increase over the \$1.828,834.86 reported last year.

Half of the collection from parishes staffed by religious priests will be returned to their communities. In 2013, \$162,662.02 of the 2012 collection was forwarded to the religious orders for the support of their seminarians.

Archdiocesan seminarians study not only at St. Mary Seminary in Houston, but also in Dallas. San Antonio, St. Benedict, Louisiana, and Rome. The total budget for the fiscal year 2013-14 is \$5,347,709.00. This includes the costs associated with the operating of St. Mary Seminary as well as the expenses of the education of seminarians, the continuing education of priests and the training of permanent deacons and laity. Of this amount, the archdiocesan subsidy is \$3,518,874.14.

The Trust Fund is able to cover about half the expense, but the collection is truly required to make up the balance of funds needed. A generous response from each parish is deeply appreciated and needed. Please remember that the total offertory collection for the weekend of June 1-2 is to be forwarded to the Chancery by June 30th.

I ask you to print the announcement below in your parish bulletin for the weekend prior to the collection.



## \*\*\*\*\* IMPORTANT NOTICE \*\*\*\*\*\* NEW FORM I-9

#### USE MANDATED EFFECTIVE MAY 7, 2013 FOR ALL NEW HIRES

In 1986, the U.S. government began requiring the use of an I-9 Form to verify the eligibility of individuals to work lawfully in the U.S. Since that time, all employers have been required to complete and retain these I-9 forms for each employee on staff, regardless of national origin, full or part-time status. All of our parishes and schools have been complying with this requirement since that time.

The Department of Homeland Security through the U.S. Citizenship and Immigration Services (USCIS) has issued notice that the Form I-9 has been updated. Effective May 7, 2013, all employers are required to use the new forms for ALL employees hired after that date. USCIS has indicated that there will be strict enforcement and the penalties for employers not utilizing the new form are \$110-\$1,000 per violation. In addition, please be aware that the government has recently issued over 250,000 notices of inspections to employers across the U.S. to review the files to determine whether they are utilizing the new forms properly.
